Who we are?

The Danish Refugee Council (DRC) is a private, independent, humanitarian organization founded in 1956 currently working on all aspects of the refugee cause in more than twenty-five countries throughout the world. The aim of DRC is to protect refugees and internally displaced persons (IDPs) against persecution and to promote durable solutions to the problems of forced migration, on the basis of humanitarian principles and human rights. DRC works in accordance with the UN Conventions on Refugees and the Code of Conduct for the ICRC and NGOs in Disaster Relief.

The protection and assistance to conflict affected population is provided within a long-term, regional and rights-based approach in order to constitute a coherent and effective response to the challenges posed by today's conflicts. Assistance consists of relief and other humanitarian aid, rehabilitation, support to return and repatriation as well as promotion of long-term solutions to displacement and its causes. In addition, support and capacity building of local and national authorities and NGOs form an integral part of DRC's work.

Country and Project Background:

The Danish Refugee Council/Danish Demining Group (DRC-DDG) has been working in Sudan since 2004 and was subsequently present in South Sudan when it gained independence in 2011. DRC-DDG South Sudan programme's current focus is on supporting forcibly displaced and conflict-affected people, including refugees, internally displaced persons (IDPs) and returnees, to access their rights in a safe and secure environment. Currently DRC-DDG is operational in Greater Equatoria, Unity and Upper Nile States. Currently the South Sudan Programme works in 5 field locations working in the sectors of Camp Coordination and Camp Management, Protection, Shelter/NFI, and Food Security and Livelihoods and Demining.

Purpose of the post

Overall purpose of the role:

The Senior Protection Officer will assist the Mobile Protection Manager in leading her/his team in information gathering, mission planning and deploying to hard-to-reach field locations. His/her role will be to conduct rapid protection assessments and response activities in crisis-affected areas. During assessment missions, the Senior Protection Officer will assess the protection concerns and needs of the affected population by gathering information through activities such as focus group discussions and key informant interviews with stakeholders. The Senior Protection Officer will contribute to the analysis of data collected in order to address the identified protection concerns and advocate for appropriate responses. Additionally, the Senior Protection Officer will plan and execute response activities, such as providing Individual Protection Assistance, support to Persons with Specific Needs, conducting referrals to the relevant actors and delivering training and awareness sessions for community leaders on human rights and basic protection principles. The Senior Protection Officer will throughout her/his work ensure

adherence to the Humanitarian Principles, Protection Principles, confidentiality, do-no-harm and strictly adhere to the Code of Conduct.

Responsibilities and Tasks

Responsibilities:

- Coordinate and support the team of Protection Officers during all activities with the support and guidance of the Mobile Protection Manager
- Gather information concerning security, local context, access, needs etc. in locations of interest to the Emergency Team
- Organize field missions e.g. by drafting mission safety plans, mission terms of reference, manage logistics and coordinate with stakeholders at the field level etc.
- Assist the Mobile Protection Manager in building the capacity of the Protection Officers
- During response missions, facilitate awareness raising sessions and activities in the field, disseminating information about policies, laws and entitlements relevant to the population of concern
- Ensure that the Protection Officers work as a team, and coordinate effectively within the team, as well as with other teams and departments
- Prepare all necessary documentation for each activity (including TORs, Purchase Requests, budgets etc.)
- Compile field mission reports in a timely manner
- Liaise and build partnerships with local authorities, chiefs and other relevant stakeholders in mission locations
- Assist in the collection and analysis of data, policies, laws and entitlements relevant to the affected population
- Participate in coordination meetings as requested by Protection Manager
- Perform any other duties as requested by the Protection Manager

- Remains productive when under pressure, with the ability to prioritize effectively, and respects and adheres to deadlines
- Able to work in a variety of environments and prepared to conduct field missions for a minimum of oneweek duration to remote locations with few amenities

- Energetic, hardworking and motivated
