Organization Background

Charity and Empowerment Foundation (CEF) is a non-Governmental and not for profit organization addressing the most urgent and pressing needs of the vulnerable members of the society. CEF engage communities to increase enrolment in both pre-primary and primary education. CEF establishes caregiver groups, trains school mentors, and conduct school-based campaigns to promote enrolment of out of school. PPROJECT OVERVIEW.

This project will see an outcome of children and adolescents aged 3-18, particularly girls and other vulnerable groups, having increased and more equitable access to quality basic education learning in Lakes State by the end of 2023. The above outcome will be achieved through input of-school children, IDP and host community children, adolescents/youth, aged 3-18 years have equitable access to safe and

protective learning opportunities, Improved quality of education through enhanced literacy and numeracy skills and life-skills and building resilience of conflict affected children, adolescents/youth, aged 3-18. Funding will enable maintenance of learning spaces through establishment of 6 TLS to enable continuity of Education programming, enabling new enrollments and retention of learners. Lack of intervention will erode previous gains achieved will support primary schools in Lake State. Charity and Empowerment Foundation (CEF) will establish 6 safe, gender segregated and gender sensitive latrines, 6 TLS and Conduct 6 education awareness raising activities through puppetry shows and campaigns, for boys and girls from the targeted communities on lifesaving messages including WASH, child protection, girl child education.

Scope of Work

Under the direct supervision and guidance of the organization field Coordinator and SOUTH Education Manager, the incumbent will be responsible for supporting coordination and monitoring all construction works in the field including the organization offices both in Juba and Field Offices and providing technical support on managing construction and renovation activities.

Main Duties and Responsibilities

- Conduct the kick-off meeting of construction works with the construction company, the engineering firm, and relevant government counterparts.
- Provide close monitoring of construction activities by undertaking regular site visits and conducting regular technical meetings including joint monitoring with relevant Government technical services; follow up progress for each activity per milestones and review site supervision.

- Check technical documents related to construction (design drawings, technical specifications, and bills of quantities); verify whether they are clear, complete, and compliant with programmatic and construction needs, eco-efficiency, and accessibility requirements; undertake the actions required to endorse these technical documents by relevant ministries.
- Follow up with the designing firms and government entities for obtaining all permits required for construction activities prior to initiating works.
- reports to ensure work compliance with norms, standards, and timeline; verify quality and precautions on health and safety standards on the ground.
- Use effective monitoring and supervision tools to easily ensure assessment of works
 quality, progress, and performance of engineering firms and construction companies
 during the entire duration of the project; apply the multi-layered approach to
 construction supervision and quality assurance; use documented hold and inspection
 points, where applicable.
- Participate in the partial, substantial, and final reception of works after verifying the correction of all defects during the Defects Liability Period, prepare and issue relevant completion certificates.
- Provide support to the organization contract Administrator on contract management, amendments, variations, duration extensions, applying liquidated damages, etc.
 Ensure all documents/information required for contract management are available of complete, and properly archived.
