# **ROLE PURPOSE:**

The post holder will be responsible for child protection program data management including supporting the CPIMS+ Coordinator with management of the Child Protection Information Management System (CPIMS+). The role holder will ensure correct data entry, safe custody of all quantitative and qualitative data related to Case Management/Family Tracing and Reunification (FTR) in accordance with Case Management Standard Operating Procedures (SOPs). S/he will be responsible for ensuring timely submission of weekly CM/UASC and 5Ws (Online KOBO) reports

# **KEY AREAS OF ACCOUNTABILITY:**

• Implement and promote the information management for case management guidance framework for ensuring best practices of confidentiality and safeguarding of children. It includes monitoring and supporting staff and other partners' adherence to it.





- Review case load and monitor statistics with the SCI field CP Coordinators; setting targets for case follow-ups and closure and identifying gaps as appropriate.
- Responsible in ensuring child protection 5Ws from all the field officers are submitted on time to CPAoR using the online KOBO tool
- Liaising with MEAL team in undertaking capacity gap assessment and following up with flags from Commcare system
- Supports the CPIMS+ Coordinator in training data clerks, case workers, case officers and community volunteers on identifying and registering cases in the community who meets the organizational vulnerability criteria
- Assisit in collecting, reviewing and screening all data from the field locations before submitting to the CPIMS+
   Coordinator and other CP staff and before sharing it with national level partners.
- Assist in identifying and supporting the establishment of adequate, effective and appropriate mechanisms to facilitate case management coordination and capacity building
- Assist in track individual cases that have outstanding/overdue actions and work closely with the FTR and CP teams to ensure progress on these cases (with implementing partners and SCI)
- Supports the coordinator in ensuring adequate stocks and management of all case management toolkits; booklets or forms and files in consultation with the CPIMS+ Coordinator

Conduct field support supervision, coaching, auditing and on-job training
