### Purpose of the position:

The WASH officer is responsible for the Supervision, field level coordination and management of site level WASH operations in co-operation with field level stakeholders. The Officer will ensure the field-level implementation and lead in implementing activities that will rapid reduction in risk of WASH related diseases and efficient, effective and integrated Livelihoods and WASH activities. In support of the World Vision operation, the WASH Officer guides and develops the activity plan for implementation of activities, assessments and monitoring activities. This must build on evidence, best practices, solid understanding and participation of local communities, the changing external humanitarian context, the interests and capacities of the host community and internal and external stakeholders. The WASH Officer works closely with the Health Coordinator and Hygiene promoters, WASH Engineering Manager and others to set up the necessary steps for guaranteeing that health and dignity considerations and needs are met in the immediate response through high quality, effective and appropriate WASH interventions. This includes direct support to WASH programming implementation that builds upon community capacities.

### Major Roles and Responsibilities:

- Providing advice and support on technical WASH Component
- Coordinate hygiene, sanitation and community participation activities of the organization with line departments (county Rural Water Supply and Sanitation Officer, RRC etc.)
- Organize and coordinate distribution of soap and sanitary kits to IDPs sites and school girls of reproductive age
- Support in the design and supervision of boreholes and water yards, latrines, solid waste pit construction and rehabilitation
- Coordinate with the department of public utility, the relevant authorities, the cluster agencies and community leaders for the involvement of all stakeholders and sustainability of the program
- Carry out assessments and other relevant studies, individually or with partners
- Actively mobilize communities for their participation and involvement in WASH projects.

- Lead in field activity monitoring
- Leads in mainstreaming gender, protection disability and inclusion and safeguarding in WASH activities.
- Planning and implementation of hygiene promotion training and practical activities for IDPs, primary schools, students and staff.
- Planning and implementation of water management and hand-pump care takers trainings and supervision of water management committees work, in coordination with the relevant stakeholders
- Facilitation community hygiene promotion through community meetings, in schools, health facilities, campaigns, radio program and social occasions.
- Conduct campaigns in the IPDs sites on emergency construction of pit latrines and seeking always for the maximum involvement of the community.
- Monitoring access to water and water quality testing through regular water quality analysis and ensure disinfection of any water sources which show contamination
- Supervise all the WASH hardware constructions ensuring that they are done following World Vision International guidelines.
- Regular monitoring and follow up of partners to ensure the proper implementation of planned activities by coordinating with the field office.
- Ensure regular and timely documentation of and reporting of the WASH activities, the general WASH situation in IDPs sites and collection of project indictors according to World Vision International and donor standards.
- Perform any other program or operations duty assigned by the WASH Project Manager

## Qualifications: Education/Knowledge/Technical Skills and Experience:

The following maybe acquired through a combination of formal or self-education, prior experience or on-the-job training:

- Minimum Qualification required: BSc. (Degree) in Civil/Water Engineering or Building Construction.
- A Diploma holder with 8-10 years of experience can apply.
- Minimum 2 years' experience in infrastructure works or in Water and/or Sanitation Project implementation as well as one-year prior experience in fragile context programming.
- Experience supervising construction teams/contractors in water supply and sanitation construction works.
- Experience in the use of Engineering software like AutoCAD, ArchiCAD, Water and others is required.
- Computer literacy on the use of MS Office, email, etc required.
- Skills in project management, including managing resources, and financial and budget planning.
- Experience and skills in community mobilization.
- Skills in Hygiene Promotion, Community Total-led Sanitation (CLTS) and Participatory Hygiene and Sanitation Tools Methodology (PHAST) desirable.
- Skills and experience in conducting water quality analysis using portable water testing kits.
- Excellent oral and written communication skills in English. Having demonstrated organizational, interpersonal and communication skills; organized, efficient, and able to work long hours to meet deadlines.
- Willingness to work under pressure in unstable security and remote location with basic necessities a big plus.
