



General Context

The Dutch organization HealthNet TPO is a knowledge-driven, non-profit organization that works in areas disrupted by war, disasters and poverty. Working together with local populations it works on rehabilitation and sustainable health care development. HealthNet TPO's programme in South Sudan dates from 1996. HealthNet TPO aims to contribute to improving the overall health situation and supports the development of systems. HealthNet TPO contributes to community mobilization as a conditional necessity in populations recovering from long-time warfare. In doing so HealthNet TPO aims to include and build the capacity of Sudanese organizations, communities and authorities. HealthNet TPO aims to develop evidence-based interventions for sustainable development of populations in distress. Currently HealthNet works in Western Bahr el Ghazal (WBEG) State, Northern Bahr el Ghazal (NBEG), With satellite offices in these States, it has its Country Offices in Juba.

HealthNet TPO is anticipating funding from PSI, under the Global Fund malaria grant, and therefore seeking for qualified, dynamic candidates for LLIN Distribution Coordinator position for Eastern Equatoria State, to support distribution of long lasting insecticide-treated mosquito nets (LLIN) via mass distribution campaigns across all the 8 counties. The role of the county LLIN Distribution Coordinator is to act as the focal point for HealthNet TPO at the county level and to ensure smooth implementation of all distribution related activities. This is a 3-month consultancy position based in County.

Purpose Position: To coordinate all the project activities based on the National Ministry of Health (MoH) Methodology for Mass Distribution of Long-Lasting Insecticide-Treated Mosquito Nets in Southern Sudan. The position is responsible for mobilization of targeted stakeholders; coordination of training activities at the County, Payam and Boma levels; support the logistics activities (oversee LLIN reception at the County level and transport from the County stores to the pre-positioning sites/distribution points); and supervision and monitoring of County, Payam, and Boma level activities during the household registration, LLIN distribution and post distribution phases of the campaign.

Key Duties and Responsibility:

- Represent HealthNet TPO in building consensus on LLIN implementation modalities with the County and Payam authorities and in close corporation coordinate with State Ministry of Health (SMoH), County Health Officers and other relevant stakeholders
- In consultation with the State LLIN Coordinator, develop distribution schedules based on accessibility and prevailing security situation
- Coordinating simultaneous distributions at the county and payam level
- Providing logistical support for mass distribution as well as consolidating LLINs to one central location after distribution as part of clean-up
- Implementing communications strategy at county levels as well as identifying non-traditional methods of transmitting information to LLIN recipients



- Coordinate with Payam Distribution Assistants, Supervisors, and Site Managers to ensure that correct information is captured during and post distributions exercise.
- Support identification and recruitment of field-based team and manage the community volunteers
- Participate in training and provide technical support to the community volunteers to effectively executing the roles during LLIN mass campaign
- Collaborating with partner organizations to help execute distributions at the county level
- Carry out IEC activities related to LLIN distribution at the state level
- Prepare progress reports on the LLIN distribution activities
- Responsible for management and distribution of all related materials to LLIN distribution
- Any other activities as requested by the State LLIN Distribution Coordinator

Knowledge and Skill Requirements for the position

- Professional Degree or Diploma on Social Services/Development Studies or related studies from recognized institution
- Minimum of two years working experience in a similar position preferable with an International NGO or relevant government departments
- Demonstrated ability and affinity to work with local Governments and other local authorities to plan, coordinate, implement and monitor improvements in development activities in the area of operation.
- Advanced training skills with proven knowledge of adult education and community mobilization
- Strong communication skills with excellent written and spoken English
- Advance computer skills including Word, Excel PowerPoint Access Outlook as well the use of the internet
- Knowledge of spoken Arabic and local languages
- Ability to work under remote field conditions

Competencies

- Able to work in a culturally diverse environment;
- Able to work with minimum supervision and be pro-active;
- Able to work under pressure, occasional flexibility in terms of working off hours
