CMMB has been working in South Sudan for over a decade providing a package of integrated health services to vulnerable populations through its Children And Mothers Partnerships (CHAMPS) program. CHAMPS focuses on redressing issues that affect the health and wellbeing of mothers, children and newborns. CMMB supports the Ministry of Health (MOH), working with other health partners, to provide a continuum of care through integrated health services (MNCH, nutrition, WASH, Child Protection and GBV) and health infrastructure strengthening at the community, facility, County and State levels. CMMB also supports Health Information System strengthening through accurate and timely electronic systems, reproducing, and disseminating health registers and training of SMOH data clerks.

KEY RESPONSIBILITIES:

- Maintain accurate and up to date records of every sub-grantee under CMMB South Sudan's program portfolio.
- · Lead capacity assessments of all sub-grantees, document the outcomes to ensure an action plan is agreed.
- · Lead CMMB's follow-up regarding the action plan and produce update reports to certify progress and highlight remaining areas for focus.
- · Work with sub-grantees to they can submit on-time and complete budgets, payment requests, and expenditure retirements.
- Coordinate learning exchanges (virtual meetings etc.) between sub-grantees as appropriate, considering the different roles each one has in CMMB South Sudan's portfolio.

Give sub-grantees the guidance they need to fully comply with the donor regulations of relevance to their sub-grant. Provide training as needed.





Develop projections for the grant draw down schedule for each sub-grant and monitor actual draw downs and retirement to ensure they are effectively supporting the workplan.
