### ORGANIZATIONAL BACKGROUND



#### **I. Purpose of the MAMI country coordinator Position:**

As part of above objective MIHR South Sudan will engage the expected international consultant to work with the Country coordinator who is tasked to coordinate the integration of MAMI care pathway in to MNCH services at selected MIHR health facilities.

- To carry on sensitization meetings with state and county government officials on MAMI care pathway before starting of the program; meeting with Ministry of Health, County health department, community leaders and selected health facilities in-charges.
- Integration of MAMI care pathway in to routine MNCH services and actual data collection.
- To supervise the counsellors and the CHWs at the health facilities and community level.
- To document lesson learned and debrief with State, County, and local government officials on MAMI after the Care Pathway has been integrated into routine MNCH services.

#### **II. Activities/Tasks for the country coordinator**



As part of this work, an international consultant with expertise in MAMI will be hired. It is expected that the MAMI country coordinator will work closely with the international consultant to carry out the activities described in this Scope of Work all activities will be conducted in coordination with the MIHR South Sudan team. This approach will pave the way for skill transfer and strengthen counsellors and CHWs including other MIHR health works capacity.

### **III. The activities/tasks are as follows:**

1. **Training:** with the support from the international MAMI care pathway consultant to work the country coordinator in planning, organize and conduct training for MAMI counsellor and the CHWs on MAMI care pathway tools. Working with MIHR, develop a training package including jobs aids for different carders of health staff including training of trainers. Coordinate adaptation and translation of the training package including training guide on course delivery how to teach effectively and how to use job aids.
2. **Integration of MAMI care pathway in routine MNCH services:** The coordinator will carry sensibilizations meetings together with the MNCH Advisor to address the regional and district government officials on MAMI care pathway before starting of the program; meeting with Ministry of Health, County Health Department, community leaders and selected health facilities in-charges. Represent MIHR in nutrition clusters meeting or partners meetings.
3. **Supervision:** MAMI coordinator will be mandated to provide supportive supervision visit for mentoring the counsellor and CHWs at the HFs and community level. Auditing activities to monitor progress with care pathway testing and integration into MNCH through reviewing meeting to evaluate the progress reports of Mami project. Conduct quarterly remote meeting to discuss experience with the tool thus far and to recommend modification.
4. **Conducting small (Virtual/ in-person) workshops:** to conduct in- person workshop with the facility works and CHWs to discuss experiences (recommend modification) concerning testing of MAMI Care Pathway.

### **IV. Deliverables:**

- Monthly report on the MAMI care pathway progress from the three selected health facilities
- De-brief presentation to MIHR South Sudan/HQ/USAID about the finding of the MAMI care pathway test in MIHR selected health facilities.
- Share the lesson learn from the MAMI care pathway test.

### **Qualification and experience required:**

1. Bachelor's degree in nutrition, Medicine, or public health
2. Extensive experiences working in MNCH/ Nutrition programming platforms (PNC, IMNCI and ICCM is prerequisites)
3. 3 to 5 years experiences working in the humanitarian setting preferable in the field of MNCH or Nutrition
4. Extensive experiences in organizing trainings in the use of tools (preferably new-born and child health, Nutrition, and mental tools)
5. Attention to details ability to monitor others and follow through on tasks in timely fashion

6. Strong communication skills
7. Ability to work as part of team leader including field travel.
