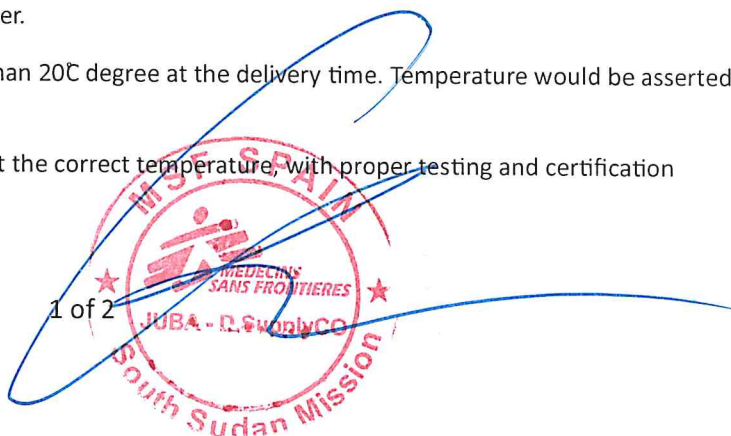

Fuel shall be in full conformity with the following specifications:

- The Goods shall be of high quality and have a density between 775 and 840 kg/m³ at 15°C.
- Goods shall be the appropriate fuel, and the fuel type shall be pure Jet A-1 fuel, conforming to the latest version of ASTM D1655 or DEF STAN 91-091 standards.
- Fuel quality shall be guaranteed by careful attention to protect the fuel against all forms of accidental or voluntary pollution.
- No impurities, dust, other liquids such as gasoline, water, tar, or other unwanted chemical substances shall be present in the Goods or added to the Goods.
- The fuel shall be free of any visible particles and water.
- During the summertime, Goods shall not be lower than 20°C degree at the delivery time. Temperature would be asserted by testing of the fuel gage.
- The supplier must ensure that the fuel is delivered at the correct temperature, with proper testing and certification





Companies that are specialized, qualified in supply of JET A1 fuel with their own facilities and stock on hand in South Sudan and meet the following criteria are invited to reply to this Expression of Interest:

- Companies must be registered with all relevant local authorities and have all the required valid licenses, tax clearances and work permits.
- Companies must have a minimum of three years of relevant experience in such type of supply with references for at least three of their most important clients in the supply of JET A1 Fuel.
- Companies must have sufficient operational and financial capacity to fulfill MSF operational requirements when needed.
- Companies must have strong communication and administrative capacity (such as efficient communication means, tracking systems, invoicing and records keeping), responsive and have/able to assign active supply focal points in South Sudan.
- Companies must have their own fuel facilities /stations/stock on hands.
- Companies must have the ability to deliver products to MSF destination, safely in good condition and on time.

3. JET A1 Fuel specification details and Certificate of Fuel Quality from SS National Bureau of Standards.
4. Copy of work permit from Ministry of Oil in SS.
5. Copy of company Operation License
6. Copy of Tax Registration Certificate
7. Copy of Tax Clearance Certificate
8. Copy of Certificate of Incorporation.
9. Letter from your bank with details of your bank account, swift and solvency.
10. References Check list for at least three of their most important clients specifically in JET A1 Fuel supply, including the contact's name, title, Email address, phone number, **items list supplied, the duration of the contracts, and contract values and proof of supplies done.**

Your reply must be sent no later than 19th March 2025.

Important Note: This EOI is not a tender, and rates are not being requested at this stage. Accordingly, please note that neither this Expression of Interest nor the receipt of company pre-qualification documents bind MSF to issue any tenders or contracts to any such interested parties. Following the assessment of applications, MSF reserves the right to accept or reject your interest to be included in MSF's Supplier's shortlist based on requirements.
