Background / Rationale

National Christian Development Organization (NCDO) is nongovernmental and non-profit making organization; it was first established in Sudan in 2005 and was later extended to South Sudan in 2011. The establishment of NCDO was due to the great need of the marginalized Sudanese and South Sudanese people on areas of water, health and sanitation, education and many others that could best be met by a local organization at the grass roots for a change to be realized.

LM International and National Christian Development Organization (NCDO), successfully implemented of UNICEF WASH activities in South Kordofan State (SPLA-N) controlled areas since 2020. Currently, it is evident that the need to provide additional WASH facilities and services is critical not only in South Kordofan State but also in Blue Nile State. For the purpose of sustainability there is need to strengthen the Institutional WASH governance and systems in SPLM-N controlled territories in the Two Areas.

Given the scale of the practice of open defecation in communities, LM International and National Christian Development Organization (NCDO) will create awareness in rural communities to understand and realise the negative effects of poor sanitation and empowers them to collectively find solutions to their inadequate sanitation situation. In collaboration with the Secretariat of Health, LM International and national Christian Development Organization (NCDO) and UNICEF will increase access to improved sanitation applying the Community Led Total Sanitation (CLTS) approach. Triggering and consequent monitoring of 35 villages.

Purpose Of the Assignment

The incumbent will train NCDO Field staff for 5 days in the implementation of Community Lead to Total Sanitation (CLTS) in 3 locations.

Estimated Duration of Contract

The trainings will run from $10^{th} - 24^{th}$ June 2024) in 3 project locations. Extension of the duration of the contract will be upon the agreement of the two (2) parties in writing.
