The price quoted by the tenderer shall not be subject to adjustments within the first twelve (12) months on any account except as otherwise provided in the conditions of the contract.

The Financial Proposal must be presented in United States Dollars (USD) only in Annex 2.

The service fee on this contract is fixed as shall be provided in Annex 2-Tender Submission Form of the tender dossier until the end of the contract period. It shall be the sole remuneration owed by the Contracting Authority to the Contractor under the contract.

The Contractor holds the right to submit a price change proposal to the Contracting Authority after the twelve (12) months with a breakdown of changes in the costs and reasons. Proposals for price changes must be submitted to the Contracting Authority, in written, at least four (4) months prior to the change proposed, only after the period stated above. Prices can be changed only once during the calendar year.

The Contracting Authority holds the right to accept or reject the price change proposal and can only come into force if it is approved, in written, by the Contracting Authority.

If the Contracting Authority doesn't approve the adjusted prices or pricing methods and no unanimous decision can be reached in two (2) months after the written proposal for adjustments, either Party has right to terminate the contract. The termination will take effect on the same day as the prices would be subject to adjustment.

- 4. Any envelope that may be submitted unsealed and marked as required will be rejected during the opening session by the procurement committee.

A.1. Eligibility and qualification requirements:

Submissions should include valid <u>registration and operation documents</u> i.e.

- a. Certificate of Incorporation from the Ministry of Justice including the renewal stamps.
- b. Membership Certificate
- c. Tax Identification Certificate
- d. Tax Clearance Certificate
- e. Operation Licence from the State Ministry of Finance & Economic Development
- f. Shipping License from the Ministry of Transport, Directorate of River Transport
- g. Quotation Validity of 12 months

Tenderers shall in the Tender Submission Form attest that they meet the above eligibility criteria (valid registration and operation documents). If required by the Contracting Authority, the accepted Tenderer shall further provide evidence satisfactory to the Contracting Authority of its eligibility through certificates issued by competent authorities in its country of establishment or operation, or, if such certificates are not available, through a sworn statement.

Tenderers shall also be requested to certify that they comply with article 13. "Child Labour & Forced Labour" and article 14. "Mines" of the General Terms and Conditions for Supply Contracts.

To give evidence of their capability and adequate resources Tenderers shall provide the information and the documents requested in the Tender Dossier.
