  - b. Deliver the Vehicle within the set and mutually agreed delivery period
  - c. Under no circumstances, withdraw its Bid once it has been accepted.
  - d. Accept and sign the ZOA Supplier Code of Conduct once awarded the contract
- 4. The bidder shall bear all costs associated with the preparation and submission of its quotation and ZOA shall, in no case, be held responsible or liable for these costs, regardless of the conduct or outcome of the bidding process.
- Each bidder will participate in and submit two quotations (For DUTY FREE & For DUTY PAID). This rule applies equally to companies within the same group of companies with the same ownership.
- Bidders shall prepare and submit quotations independently and without any connection, knowledge, comparison of information or arrangement, direct or indirect, with any other bidder.
- 7. The bidder is expected to carefully examine the contents of its quotation. Failure to comply with the requirements of the RFQ shall be at the bidder's own risk. Bids not submitted in conformity with the above bidding Conditions shall be rejected.

- 13. Information relating to the examination, clarification, evaluation and comparison of Quotations and recommendations for the award of the contract will not be disclosed with the process of evaluation. Any effort by a bidder to influence ZOA's processing of the Quotations or award decisions may result in the rejection of its bid.
- 14. Information contained in and with the RFQ is considered proprietary in nature and is to remain confidential between ZOA and the bidder. Access to these materials shall not be granted to third parties without the prior written consent of ZOA.

#### Part IV: Award of Contract

- 15. Bids must be received by ZOA in the manner specified on or before the deadline date on page 1 of the RFQ.
- ZOA, in its sole and unfettered discretion, reserves the right to accept your Submission in whole or part.
- 17. ZOA reserves the right to negotiate with one or more of the bidders, seek clarification from bidders regarding their bids and invite modifications to the bids submitted.
