## Terms of Reference (T.o.R) for Provision of Security Services

#### Title of the Activity

Provision of Security Services

#### Overall Objective/Description

The Contracted Company shall be engaged for the purpose of provision of Security and Cleaning services, including preventing unauthorized persons from entering the premises safeguarding and protecting the perimeter, buildings, vehicles, machinery, equipment, supplies, materials, and other properties such as offices and facilities of the client in WES: Yambio, Nzara, Ezo, Tambura, Mvolo, Nagero, Mundri East & West, and CES: Juba, Lanya, Kajo- Keji & Yei.
