Job purpose:

Under direct supervision of the project manager, the Project Officer shall be responsible for co-ordinating all SRHR activities including GBV prevention and response in the UNFPA Project. The scope of work shall include: planning with team members, participating in technical implementation of activities, reporting, stakeholder engagement and team leadership.

Key Responsibilities:

Planning & Coordination

- Lead the field team in development of monthly, quarterly plans and budgets for all SRHR activities for all project sites
- Coordinate the field team and ensure that the project's administrative processes and polices related to logistics, procurement and finance are fully implemented according to Amref Health Africa and donor requirements
- Take lead in facilitating the procurement and logistics of the RH supplies for the SRHR
- Collaborate with the Project manager in order to actively participate in rnonthly and quarterly planning and review meetings of the project and follow up actions for implementation

Technical Implementation

- Ensure that SRHR activities in all field sites are efficiently and timely implemented in line with the approved work plan and budgets
- Ensure that the implementation challenges are addressed; lessons are identified, documented and reported for incorporation into future plans.





- Provide regular guidance and support supervision to the one-stop center staffs with and the adolescent and youth friendly services.
- Regularly participate in community outreaches and radio talk shows, social campaigns and other functions related to SRHR
- Actively participate in the development, production and adaption of appropriate IEC materials for the project
- Participate in training and organizing training in matters related to SRHR including FP, CSE, Peer Educations and GBV.

- Support the Boma Health Workers (BHTs) in carrying out their roles related to the community
