PURPOSE AND SUMMARY OF THE POSITION

The food security and livelihood officer will implement the SIDA Multi-sectoral project funded by Swedish government. The multi-sectoral project includes nutrition, health, WASH and food security program for one year.

Under the direct supervision of the Head of food security and livelihood, S/he will performs a variety of specialized technical tasks in the field of agronomy; direct project activity implementation including selection of project implementation locations, coordinating provision of agricultural inputs and tools, maintains records of beneficiaries, distributions and s/he will provide overall technical support to project beneficiaries through trainings, experiments, setting demonstrations gardens and developing production methods to improve household food production and income of host communities. The food security officer will ensure integration of food security in to nutrition project by supporting nutrition sites through establishing kitchen/demonstration gardens and support targeted communities.

TASK & RESPONSIBILITIES

Key to the role is overseeing quality and timely implementation of Food Security and Livelihood interventions to ensure continuity of effective service delivery and save lives. The Selected Candidate's Roles and Responsibilities will include but not limited to the following:-

- ❖ Oversee the implementation of activities and ensure activities are implemented in a timely manner and meeting the standards.
- ❖ Develop plans for the implementation of the FSL project in the assigned Payams and Bomas.
- ❖ Oversees the Agriculture & Infrastructure Supervisors, and work closely with M&E Officer to ensure that programme indicators, monitoring formats, databases, data analysis, and reporting are maintained and harmonized.
- ❖ Identify community needs, understand the natural resource management challenges and suggest potential solutions appropriate to the programme.



- ❖ Through guidance support from FSL head, suggest innovative ideas and appropriate techniques for FSL interventions based on the context.
- ❖ Provide standards on job training and guidance on crop/vegetable production management practices, cash for asset implementation and resources management to project assistants, community supervisors/volunteers and field monitors.
- ❖ Ensure project plans, reports (activity weekly, monthly, quarterly and annual reports) etc. are prepared and submitted timely.
- ❖ Support the M&E in ensuring correct data collected providing regular activity monitoring, follow up and provide report on project key issues and any other challenge affecting the project.
- ❖ Provide supervision to the project assistance and supporting staffs and ensures technical support provided at field level.
- ❖ Work closely with finance to ensure review of project expenditure to avoid under/overspending and with the logistics ensuring all project material, equipment orders are placed, and purchases on time according to procurement plan.
- ❖ Represent ACF in sub-cluster meetings in the field level and provided update to the head of FSL and nutrition program manager field based.
- ❖ Take active role in all FSL related aspects in case of any emergency, under the guidance of head FSL.
- ❖ Ensure active liaison with communities to ensure proper flow of information with respect to ACF's role and community's needs.
- ❖ To travel and actively participate in implementation of emergency FSL intervention to places assigned by manager.
- ❖ Perform any other duty as requested by line managers.

- ❖ Head of FSL: functional relationship – technical supervision and support – exchange of information
- ❖ Nutrition program manager: hierarchical relationship, reporting lines, support.
- ❖ Others Programme staff: exchange of information and coordination with FSL team and other programs to maximize the impact of activities.

Local Authorities and Partners: exchange of information, coordination, training.

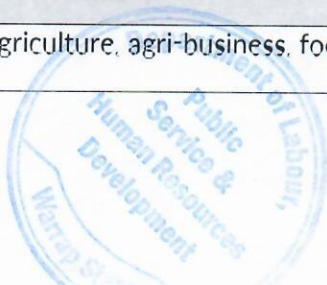
