I. Background

The Afia WASH project is a five-year, USAID funded project (October 2021-September 2026) that aims at expanding gender-transformative and sustainable access to basic safe drinking water, basic sanitation coverage, and increased uptake of key hygiene behaviors for the purpose of improving health and household resilience in accordance with USAID/South Sudan's Strategic Framework 2020 – 2024

Afia WASH is therefore inviting interested, eligible and competent Companies and Service providers to express their Interest to be considered to receive the request for proposal to support the Project Documentary Film Production in Kapoeta North County.

2. The principal objective of the assignment:

The main scope of this assignment is for a professional documentary filmmaker with ability to produce a documentary film highlighting challenges, Afia WASH approaches and impact of interventions on the selected local communities in Kapoeta North County. The documentary is to be empathy driven, moving and motivational, told mainly from the perspective of the affected community. The film will be produced in the local language with Options for English subtitles, at highest market quality standards, high definition, with clean stylistic touches.

3. Eligibility/Criteria for selection

- Legally registered in South Sudan [Valid legal certificate]
- Have been in operation for at least three years from the time of registration.
- Demonstrate presence or have experience in Project Documentary Film Production in South Sudan.
- Availability of experienced film production team members. The team should comprise of at least a Director, Producer
 and Videographer. While we are not expecting CVs for the documentary film production team members, you should
 provide a paragraph on each of the staff members that will form part of the film production team not more than a
 paragraph or a quarter of a page. Briefly provide qualifications, experience in similar type of work, the role that the
 person typically plays etc.].
- Proven organizational capacity to undertake such type of work (size of the organization i.e., number of employees, your annual budget etc. contacts of referees (see below) that we can contact to verify your work)

Bidders are required to provide contact details and at least two letters of satisfactory completion of assignments of a similar nature.

4. Mode of Submission:

- Applicants must submit adequate information on their Legal corporate status, including but not limited to Company Name, proof of Physical Location, Telephone number, and Contact person.
- Shortlisted organizations will be requested to submit full detailed Technical and Financial proposals separately. The exercise towards realizing contract award shall be transparent and competitive.
- Interested organizations MUST submit their Expression of Interest (EOI) to the undersigned not later than Wednesday March 8, 2023

5. Submission Guidelines

EOI should be in English Language and not exceed ten (10) pages (excluding cover page, executive summary, and annexes). Any EOI with more than 10 pages will NOT BE considered responsive at all and will be rejected.
