Background

The Child Relief and Support Organization (CRSO) is a non discriminating national non-governmental organization that works for the protection of children's rights and their families.

CRSO's mission is the protection of children at risk of harm, as well as the prevention of any form of abuse, violence and exploitation.

Together with interventions aimed at helping **children** in distress, abandoned or victims of abuses, CRSO supports programs of emergency relief and sustainable development in the field of health, education, Protection, Food Security and Livelihoods, Water, Sanitation and hygiene promotion and Relief/Emmergency responses.

CRSO is in the process of hiring Food Security and Livelihoods Project Assistant. Under the overall guidance and directly reporting to the Programme Manager, the Food Security and livelihoods Project Assistant shall be responsible for the planning, implementation, monitoring and evaluation of an anticipated 'Integrated Livelihood and Education Response in Magwi County in accordance with the project dcouments and donor requirements, detailed in the duties and responsibility section.

Duties and Responsibilities



The FSL Project Assistant is part of the key project implementation team at the field level and will be required to execute his/her roles with diligence, expertise and tact towards the achievement of project objectivities, CRSO aspirations and our vision for children.

The FSL Project Assistant will work with the Programme Manager, Community based facilitators, Community Animators, County Department of Agriculture and the target communities to ensure that project activities comply with Ministry of Agriculture and other Food Security Response guidelines including SPHERE standards. He/she will be responsible to contribute to the implementation of all the project activities in the project location in addition to maintaining the relation between CRSO and different stakeholders on the ground in order to achieve all the intended objectives under this project. More specifically, the FSL Project Assistant will be responsible for the following:

- Implementing all activities under the livelihoods portfolio in the project location, in line with all livelihoods tools, policies and procedures;
- Conduct livelihoods assessments including labour market, capacity/skills assessments, gender analysis value chain analysis and supply chain mapping, under the guidance of the programme Manager.
- In coordination with other teams, assist in the identification and selection of individuals for livelihoods assistance, in line with project guidelines
- In collaboration with the programme manager, take some responsibilities for ensuring understanding and compliance amongst project staff to security and health and policy, and any accidents or potential incidents are recorded
- Responsible for induction of his/her own staff, ensuring their familiarity with CRSO's mandate, values, Quality Standards, policies and programme objectives and their individual responsibilities in upholding these standards and policies.
- Identify key stakeholders and build relationships with local authorities, associations, Unions, and other locally active actors to implement the SF supported livelihoods project;
- Support selected beneficiaries by facilitating orientation meetings and/or business trainings and/or counseling as necessary and provide support to them in the formulation of their business plans;
- Follow up with the field teams to quality check data and service delivery and follow up with the work plans and make recommendations where necessary;
- Support the MEAL team in organizing and conducting satisfaction and feedback surveys in order to improve future livelihoods projects:
- Take a role in the reporting of the project activities and maintaining the related activities and beneficiaries' data as per the donor rules and regulations;
- Participate in all meetings and events related to the project in the project location, including meetings with local authorities, coordination meetings, support during donor visits and any other related activities.
- Provide inputs and feedback to reporting
- Perform such other duties as may be assigned by the supervisor.
