<b>Job Title:</b> Nutrition Nurses (03)	<b>Expected Start Date:</b> 15 September, 2025
<b>Reporting to:</b> Nutrition Supervisor and works closely with Nutrition Manager, Project Finance In-Charge, MEAL Coordinator and Safety & Operations Manager.	
<b>Basic Position Description:</b> Position is responsible for better nutrition among communities through treatment clinical symptoms of severe acute malnutrition and prevention of further deterioration of the nutrition situation among children under 5 and pregnant and lactating mothers through provision of therapeutic food, routine drugs, health and nutrition education and capacity building and technical support to the CHD in the management of severe acute malnutrition.	
<b>Country:</b> South Sudan	Field Based - Pibor, Greater Pibor Administrative Area (GPAA)
<b>Contract Duration</b>	10 Months - full time & fixed term, renewable based on performance and availability of funds.

## **Background:**

The Christian Mission for Development (CMD), in an enduring partnership with South Sudan Humanitarian Funds is implementing a 10-month Nutrition in Emergency Project in Pibor titled, "Nutrition and FSL multisectoral Life Saving Support to Vulnerable Communities in Pibor County".

Commencing in 02nd August 2025 and running through 14<sup>th</sup> August 2026, the Project will ensure that 10,714 ( SAM 2,516, MAM 4,238 and PBW 3,960 ) vulnerable children and Pregnant and Breastfeeding Women (IDPs, returnees, refugees and host communities) in Pibor County receive lifesaving, quality and equitable through screening for early detection and treatment for acute malnutrition.

## **Main Roles & Responsibilities**

The Nutrition Nurses will perform their duties under the close supervision of CMD's Nutrition Supervisor. Specific responsibilities will include:

*Objective 1:* Ensure effective management of clinical and other related ailments at OTP/TSFP

*Objective 2:* Supervise activities at the OTP/SFP

*Objective 3:* Network and coordinate with the relevant sectors

## **TASK & RESPONSABILITIES**

*Objective 1:* Ensure effective management of clinical and other ailments at OTP/TSFP

- Plan and organize OTP/SFP at designated distribution sites in liaison with OTP/TSFP Supervisor.

- Work closely with SFP staffs to ensure all aspects of the programme are understood and agreed and appropriate referrals take place to and from the TSFP.

- Prepare plan of action for effective OTP implementation in consultation with the OTP/SFP Supervisor.

- Supervise the activities of the CMAM team (registrar, Community Nutrition Volunteers, Boma health workers)
- Work closely with the teams to ensure all children are screened correctly
- Ensure all criteria are respected and understood by the teams, including admission, discharge and transfer to and from the OTP/SFP
- Ensure comprehensive health checks and treatment according to the protocols
- Review the forms completed by staff to ensure completion, accuracy and coherence

-Ensure adequate availability of all medical and food supplies and ensure stock is pre-positioned as planned by discussing with logistics

- Follow-up and provide feedback to the OTP/SFP Supervisor on the amount and quality of the treatment supplies if it does not comply with specified quality standards.
- Report on progress and any problems in a timely manner
- Ensure cases not meeting admission criteria return home as early as possible and understand why their child is not admitted.
- Through liaison with the community mobilizers and nutrition volunteers, provide effective follow up of all cases: particularly tracing of children who are absent from the programme, sick children, long stay children, children not gaining weight, and children with social problems etc.
- Development of fact sheets and other training materials as required for the CHD staffs under the guidance of Nutrition Supervisor.
- Provide key health and education messages to beneficiaries based the protocol and guidelines
- Respond to inquiries regarding the technical aspects of the program admission and discharge whenever necessary at the OTP/SFP sites.
- Providing MOH/CHD staffs with technical support in convening meetings and answering questions on topics relevant to the project as necessary.
- Follow-up and ensure the field team interacts with the beneficiaries properly
- If there is a problem, find out what is wrong and find a solution or else contact your immediate supervisor
- Perform any other duties requested by the immediate supervisor.

## **Objective 2: Supervise medicines administration in OTP/TSFP activities**

- Follow and respect the current protocols specially drug administration i.e. for de-worming, malaria, polio and measles , and micronutrient mineral/ Vitamin A supplements targeting children and PLW.
- Add the activities linked to health and nutrition education in the protocols
- Follow the treatment of the beneficiaries during visits at home
- Participate in the follow-up of orders and consumption
- Analyze the nutritional situation.
- Compile the statistical data (admission, default, cured, absent, death) and draft a report on activities.

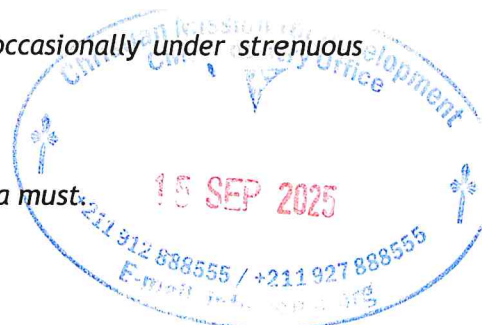
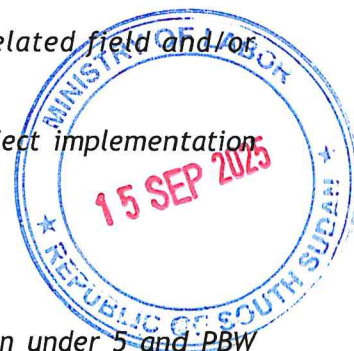
- Establish good relationship with the Pibor and local authorities and community leaders

- Establish link and meetings with the community leaders and different group existing in the working area.

## **Qualifications and Experience**

- A Certificate or Diploma in nursing or health and nutrition related field and/or a post-secondary school certificate in social sciences.
- At least 2 years of accrued working experience in Nutrition project implementation applying partnership approaches is desirable.
- Understanding of SPHERE and/or NIE minimum standards.
- Knowledge of the basics of MIYCN/CMAM national Guideline.
- Experience working with health and nutrition vulnerable children under 5 and PBW setup; MoH-level experience a plus.
- Experience in community mobilization and/or relationship building; work closely with CNV's and Mother groups.
- Experience in strategic thinking and planning skills, be able to set priorities, prepare manageable plans and to evaluate progress.
- Ability to establish and maintain conducive collegial relations and perform effectively as a member of a team.
- Willingness to travel and work in hard-to-reach areas, occasionally under strenuous conditions.
- Good knowledge about data collection, entry and analysis.
- Computer literacy and excellent documentation skills are a must.
