1.0 INTRODUCTION:

Norwegian People's Aid (NPA) South Sudan is an International Non-Governmental Organization involved in humanitarian, relief and long-term development cooperation in South Sudan. NPA has worked in South Sudan since 1986 and currently runs three programmers: Civil Society Development, Rural Development, and Emergency Response. NPA is implementing the NORAD funded Partnership for Building Resilience and Enhancing Livelihoods (BREL) project. The BREL project has been desired to improve the resilience of the target households to shocks (economic, natural and conflict related) and contribute to livelihoods through improved household's production and increased/diversified income sources. The overarching focus of the initiative is to implement of of series of interventions that promote household/community food security, build the resilience and livelihoods of conflict affected households in South Sudan. The project is being implemented through a combination of direct implementation and through Implementing Partners (IPs). The IPs consist of locally registered Local Non-Governmental Organisations (LNGOs). Attainment of the project outcomes will hinge on strengthening the capacity of national partners Organizations, smallholder farmers, groups and associations and local actors to provide an enabling environment for target households to engage in improved and more sustainable climate agriculture hence contributing to improved household production and productivity. With this background in mind NPA intends to recruit a consultant to conduct an assessment of the capacity of IPs who are engaged under the BREL project.

2.0 DESCRIPTION OF THE ASSIGNMENT:

NPA is seeking the services of an experienced consultant to conduct a capacity assessment local NGOs who are Implementing Partners (IPs) of the NORAD funded BREL project. The consultant will be expected to conduct a technical, operational and financial capacity of the IPs. The data collection will be conducted over a maximum of 14 days. The results/recommendations of the consultancy will be used to develop a capacity building plan for IPs under the action.

3.0 OBJECTIVES OF THE ASSIGNMENT:

• To conduct a capacity assessment of Implementing partners.

- Conduct in-depth assessment of the capacity of all the partners Organizations and its organs and identify capacity gaps;
- Assess capacity of the partners to ensure accountability through prevention and enforcement, strengthen national integrity of the Partner Organizations and increase public participation and build collaborations; increase mobilisation, access to and use of information, work with the international community.
- Carry out an analysis on the capacity of the IPs to mainstream gender, human rights, and environment and fully apply result-based management principles.
- Assess institutional strategy, business processes, human resource management, information, equipment and communications technology in regard to the programme;
- Assess training needs and requirement of the Implementing Partners staff implementing the programme to access to training opportunities;
- Using the information gathered from the assessments and analysis, propose for capacity development strategy and plan.

5.0 METHODOLOGY:
