1. Background

IRSS 24 months' intervention will target food-insecure and conflict-affected women, men, girls, and boys within 5 payams (Akop, Awul, Alabek, Kiriik, and Rualbet) of Tonj North. IR will prioritize PwDs, PLW, child-headed HHs, women-headed HHs, chronically ill persons, and elderly people. The project will focus on safe and gender-sensitive WASH services and culturally appropriate hygiene practices among IDPs and HCs including W/M/G/B in Tonj North. This will increase equitable access to clean drinking water for IDP and HCs, given the number of water points being rehabilitated/ constructed. For sustainability W/M in WMCs and mechanics will be trained. The project will further ensure improved access to dignified and gender-sensitive sanitation facilities among IDP and HC, as this will reduce open defecation in the community. The project will encourage the practice of safe, culturally appropriate hygiene practices among IDPs, resulting in increased proportion of W/M/G/B washing hands with water and soap or substitute, the number of people trained in key hygiene messages and community engagement approaches, and the number of people satisfied with WASH NFI and dignity kits. The project will ensure protection and inclusion of vulnerable populations and will therefore support children, women and PWDs using community structures that include Community Based Protection Committees, IR staff and experienced GBV caseworkers. Provision of gender-sensitive and culturally appropriate Dignity Kits, trainings, GBV awareness, referral pathways for survivors will be part of the activities. Recommendation from Gender and Protection Learning paper will be considered during the intervention. Strengthened community-led protection services and resources for IDPs and HCs, particularly W/G, in Tonj North, resulting in number of people with satisfied access to community-based protection mechanisms. The Nutrition interventions will enhance nutritional services for IDPs and HCs, particularly children <5 and PLW with acute malnutrition, in Tonj North. There will be an increase in knowledge through trainings in preventing, identifying, and treating S/MAM among IDPs and HCs, particularly children <5 and PLW. The project total target is 30,400 (12,000W; 5,500M; 7,900G; 5,000B) to be reached through an inclusive approach of targeting the most vulnerable persons/households from host communities and IDPs.

Outcome 1: Improved use of safe and gender-sensitive WASH services and culturally appropriate hygiene practices among IDPs and Host communities including women, men, girls and boys in Tonj North, South Sudan.


Outcome 2: Strengthened community led protection services and resources for IDPs, HCs, particularly women and girls, in Tonj North, South Sudan.

Outcome 3: Enhanced provision of quality nutritional services for IDPs, HCs particularly children under 5 and pregnant and lactating women with acute malnutrition, in Tonj North, South Sudan.

1.1 Purpose and Objectives

The Gender Analysis for this program has four objectives:

- To undertake situation analysis of the project areas to identify gender issues/dimensions/gaps with respect to natural resources management, WASH, Nutrition and Social Protection status.



- To assess gender responsiveness of the project in order to record local knowledge on gendered impacts of environmental/climate change in Tonj North
- To propose ways or strategies for dealing with risks and threats and untapped opportunities to achieve gender based targets.
- To provide specific recommendations on gender mainstreaming across project activities and identify specific consideration for mitigating and preventing GBV.

1.2 Consultant Scope of Works

The Consultant will develop an in-depth gender analysis to understand where women and men are suited in livelihoods, localized sectorial priorities and in addressing barriers for women's empowerment, decision making and participation in contributing to those priorities. The Consultant will underscore Gender mainstreaming, Gender based violence (GBV), particularly emphasizing gender issues that are not limited to division of labour, access to and control of resources, leadership and exposure to technologies promoting livelihoods in Tonj North. S/he will collect disaggregated baseline data that could be used to monitor gender impacts on risks of SEA, conflicts, in pastoralists' communities and disfranchisement of women and effects on gender relationships.

This assignment should be completed within a maximum of 30 days from inception period. Hence, the consultant will:

- Prepare a comprehensive inception report and hold inception meetings with the Project members.
- Develop a simple yet comprehensive Gender Analysis matrix describing the type and data to be collected, techniques, and relevant tools for each indicator, budget, and survey work plan.
- Define sampling method, sampling size, and targeted respondents
- Review existing literature on the state of gender roles and norms, food security and livelihoods, area IPC Analysis, relevant reports from WASH, Nutrition, GBV/Protection cluster, including the Project proposal, logical framework/TOC.

2. Methodology



2.1 Approach

The consultant will design/use a mixed approach that integrates qualitative and quantitative data collection techniques, and tools that will focus on the following areas of inquiries: gendered division of labor, household decision-making, control of productive resources, and access to services.

Quantitative: It is important to be able to acquire data that permits the program to understand gender roles and responsibilities, capacities of women, men, boys, and girls to respond to crises and vulnerabilities that exist among women and men in different locations (such as counties, payams) as per the indicators. Household surveys will be conducted to measure the selected indicators.

Qualitative: The consultant is expected to conduct Focus Group Discussions (FGDs), and Key-Informant Interviews (KIIs). Findings from this technique will be used to refine questions raised through the thematic reviews.

2.2 Sampling

The consultant will implement a sampling procedure that is representative of the project life of the project target population. The gender analysis must achieve a statistically acceptable sample size for the respective project participant categories. The consultant will develop, and abide by the approved sampling methodology. Where sampling strategy is changed for whatsoever reason, the consultant is expected to re-compute to achieve representative samples with a resubmitted sampling protocol. Therefore, a clear and unambiguous proposal on sampling methodology and the sample size is expected from the consultant. The sampling method should attain representative and generalizable results for all project participant categories.

2.3 Data Sources

The Gender Analysis will consider both **primary** and **secondary** data sources.

Primary data sources include but are not limited to household surveys, KIIs and FGDs.

The secondary data sources include but are not limited to studies from South Sudan's Nutrition, WASH and GBV/Protection cluster, IPC latest findings, other bilateral donors, and existing program documents. The consultant is expected to undertake a review of existing documents using appropriate document review tools and methods.

2.4 Location

The Gender Analysis will be conducted in Tonj North County, Warrap State of South Sudan

2.5 Data Quality Issues

The designed data collection techniques, quality of data should not be compromised and maximum care should be taken to avoid or at least minimize errors at all stages of the Gender Analysis. Some techniques such as, but are not limited to, the following will be applied:

- Before data collection: Pilot testing of the data, collection tool will be required in order to verify the reliability and validity of the tool. This includes both face-to-face and remote approaches.
- During field data collection: For household surveys, data entry will be on the spot using an electronic questionnaire. Monitoring enumerators for accuracy in doing the interview and in capturing data will be necessary. Checking through all completed responses (on a daily basis) to ensure any mistakes or inconsistencies are corrected on time will add value to the quality of data.
- Data analysis: Perform iterative data analysis which involves continuously analyzing key variables as part of data quality checks using various methods such as frequencies or cross-tabulations or any forms of regressions

2.6 Communication of Findings/Reflection

Gender Analysis findings will be validated by the key stakeholders. Once the validation is completed then the final report will be produced.

2.7 Gender Analysis Products/Deliverables

There will be key deliverables of this process:

- An inception report clearly outlining the approach, indicators, methodology and tools including any annexes



- Finalize survey tools and inclusive and gender-sensitive sampling design
- Enumerator training, tool, pre-testing and data collection
- A comprehensive and well-organized final Gender Analysis report in electronic version word and PDF-based on the template structure in the annex below and should include key findings from all four objectives mentioned at the beginning of the ToR and must also provide disaggregated data by SADD at a minimum, but also by other vulnerability criteria as relevant for the project
- Supporting files, original and cleaned datasets, statistical output files, photos, case studies etc.
- Fact sheet or abstract and Power Point presentations to be used for dissemination of results to stakeholders

2.8 Lessons Learned

The lessons learned through the entire Gender Analysis shall be documented and shared with the Project team and MEAL department so that they may be taken into consideration for future studies. The documentation of these lessons will be vital for reflection, growth, and continued improvement.

2.9 Limitations

This Gender Analysis will be undertaken with some limitations. These may include:

- **Security:** Given the current restrictions in the country, the Gender Analysis may be affected by the volatile security condition in some areas.
- **Travel Schedules:** International and domestic travel between states are mostly by air. In addition, travel schedules may change due to flight cancellations and other technical issues.
- **Statistics:** Country demographics may not be readily up-to-date hence the consultant may have to undertake additional data collaboration.

2.10 Additional Information

- Consultants shall be required to sign and abide by Islamic Relief Safeguarding Policy (which includes prevention of sexual exploitation and abuse, and behavior protocols)
- Consultants shall abide by beneficiary data privacy/management policies

2.11 Ethical Considerations, Confidentiality, and Proprietary Interests

- The Consultancy Firm holder needs to apply standard ethical principles during the course of the assignment. Some of these must deal with confidentiality of interviewee statements when necessary, refraining from making judgmental remarks about stakeholders.
- The incumbent shall not either during the term or after the termination of the assignment, disclose any proprietary or confidential information related to the service without prior written consent by the contracting authority. Proprietary interests on all materials and documents prepared by the contract holder under this assignment shall become and remain properties of Islamic Relief.

4. Consultant profile


- The consultant should preferably be a holder of a post-graduate degree in Gender and developmental studies, rural development, social sciences, or related discipline.
- Qualified and experienced consultant with FSL, Nutrition, WASH and Protection background in surveys and assessments using Gender Analysis methodology.
- Minimum experience of having led a similar survey in South Sudan
- Proven team-leading and managerial experience
- Knowledge of working with conflict-affected populations
- The consultant must have a strong background in statistics and data analysis. Must know SPSS, STATA, and all relevant computer applications in general.
- Excellent reporting and presentation skills.
- Excellent knowledge of and experience with humanitarian guidelines and principles.
- Willingness to travel extensively and work under pressure & meet deadlines
- Ability to work in a multicultural and inter-sectoral environment.
- Ability to work collaboratively as a team with the other staff members.
- Ability to coordinate, direct and supervise others to achieve a common goal.
- Ability to live and work in an isolated area in conditions of limited comfort

5. Evaluation and Award of Consultancy

- 30 % - Financial




6. Technical Evaluation Criteria

Technical Criteria	Description
General understanding of the TOR.	Does the proposal demonstrate a clear understanding of the TOR? Does the consultant make an effort to interpret the objectives?
Methodology	To what extent is the methodology clear and detailed? Is the sampling method and sample size computation scientifically acceptable? Are all the relevant methods of data collection included in the proposal?
Team composition	Does the consultant (or proposed team) have the necessary competencies and experiences as described in the TOR to undertake this Gender analysis?
Experience	Experience of conducting Gender Analysis in South Sudan, preferably within proposed geographical area has competitive advantage. Experience with similar assignments with INGOs/other organization
Work plan	Is an action plan part of the proposal? Is it reasonable or realistic? Does it meet the expected deadlines? Is it flexible to accommodate any changes without compromising the deadline and quality of products
Budget	To what extent is the presented budget reasonable? Is the budget clearly aligned with the planned amount?

9. The application process

The application should include a team composition with a Lead Consultant and at least 2 experienced evaluators. International consultants/firms must show proof of in-country capacity to carry out the evaluation. The application should include a minimum of three CVs of the persons to be involved in the assignment, relevant experience, a detailed budget in USD, and time availability.

Proposals must contain a proposed methodology, work plan and budget.
