CARE South Sudan is an International NGO working in South Sudan. CARE and its partners work with vulnerable communities to address the underlying causes of poverty and promote peace and development, through its strategic goal to reduce poverty by empowering women, enhancing access to resources and services and improving governance.

CARE South is one of the partners implementing the Fortifying Equality and Economic Diversification for Resilience (FEED II) project in Torit and Jonglei States. The FEED II will empower women to remove barriers to a) managing the risks associated with food security, b) participating in the production and sale of agriculture produce and c) participating as leaders in their communities. Over five years, the project will narrow gender gaps in agriculture.

CARE South Sudan is therefore looking for a suitable candidate to cover the position of FEED II Senior Project Officer (1), to be based in Torit Field Offices.

Purpose of the job

The Senior Project Officer will be responsible for field level planning, implementation, monitoring and evaluation of the FEED activities in the area of intervention. The SPO will supervise the implementation of food security, livelihoods, nutrition, peace building, gender and protection activities. S/he will be participating in baseline assessment, development and execution of project plans taking into consideration gender/protection mainstreaming. In consultation with the Project Manager, S/he will ensure that field staff apply effective monitoring systems to track activities implementation and financial expenditures.

The position will be based in Torit, with regular visits to project areas within the respective states. S/he will be responsible for ensuring that quality and reports are timely prepared by field teams.

Provide technical guidance and supervision to Project officers and other staff throughout the

planning and implementation of project activaties. - Promote culture of learning whereby lessons-learnt and good practices are documented and shared for institutional memory
- Ensures that CARE South Sudan's financial, procurement and compliance systems and procedures and best practices in managing resources are kept and practiced by all project staff
- Prepare location-based monthly and quarterly reports and share with the project manager
- Ensure regular monitoring and progress of project/work implementation. Ensure participation of women and girls in the project and protections issues are incorporated and mainstreamed in all sector activities
- Participate in developing and implementing information dissemination activities to publicize the project achievements and results with key stakeholders

- Promote gender equity and diversity by encouraging a gender responsive work environment and conducting gender equitable staff recruitment at field level
- Encourage and model continued learning and professional development of staff through capacity building. Responsible for Performance management of the project team including setting team and individual objectives, providing capacity building, feedback, coaching to the team to achieve targets.

- Ensure that adequate staffing is in place for the activities, including an appropriate gender balance within the teams.
