## **PURPOSE**

The RFL FO 2 will be providing RFL services in IDPs sites in the communities hosting IDPs, returnees and to the refugee population in Unity States. He will work closely with other departments of ICRC and SSRC RFL staff and volunteers.

## **FUNCTION DESCRIPTION**

- Under the supervision of the Protection Team Leader, implements the RFL activities in Bentiu, (i.e. phone
  calls, tracing cases, RCMs, RFL for vulnerable persons and unaccompanied/separated children, coordination
  with other Child Protection actors etc.) and other assigned areas.
- In close coordination with the Team Leader in charge of the AOR, attends the relevant meetings and keep the JUB RFL coordination team updated.
- Under the supervision of JUB RFL Coordination team and in coordination with Field team leader, establishes
  and maintains contacts with relevant interlocutors and stakeholders in his/her AoR (i.e. MoSW, RRC, UN
  agencies, CP actor's community leaders, civil society organizations, other relevant civilian and government
  institutions).
- Receives, processes the new cases and ensures the follow-up of cases collected in the areas that he/she has been assigned by the RFL department.
- Uses Prot6 in a regular manner, enters cases and identifies cases not treated for further actions for the
  relevant field teams.
- Ensures appropriate information flow and storage of information: maintains proper filing, prepares correspondence, photocopying, scanning.
- In close coordination with the partnership delegate, maintains regular contacts with SSRC Bentiu's branch RFL officers and carries out relevant RFL activities.
