Project Background:

Under contract with the U.S. Agency for International Development (USAID), DT Global South Sudan is implementing the five-year, Shejeh Salam Activity in South Sudan since 30 September 2020. Shejeh Salam is build a foundation for a more stable and socially cohesive South Sudan that will enable local actors to build community cohesion to promote peace processes and peaceful co-existence; civil society actors to advocate for peace and reconciliation and participate in civic processes; provide trauma awareness services to communities; and access to media that is providing accurate, fair and thorough information to mitigate the impact of rumor and misinformation. Shejeh Salam is currently programming in Juba, Unity, Upper Nile, Greater Bahr el Ghazal, Greater Jonglei, and Greater Equatorias regions, although geographic focus may shift.

Position Summary:

The Procurement Specialist is responsible for overseeing all procurement aspects of the program and reports to the Procurement Director and ensures coordination of all procurement for the operations and grants program including coordination with the field sub-offices. The Procurement Specialist supervises procurement staff as delegated by the Procurement Director and works closely with the Juba and field sub-office teams, including Program, Finance, Logistics, and Human Resources.

Duties and Responsibilities:

- Ensure cost effective and timely procurement for both operations and program requirements, while
 respecting vigorously all DT Global South Sudan / Shejeh Salam established procurement
 procedures and USAID procurement rules and regulations.
- Effect procurement actions upon approved purchase requests and ensure that all procurement actions follow the proper sequence, including receiving, preparation of bidding documentation, preparation of Contracts and/or Purchase Orders, and verifying that appropriate authorization and approvals are in place prior to issuing a Contract / PO.
- Upon request, conduct market survey and prepare appropriate bid analysis prior to executing
 procurement, including providing documentation and requests for exemption from competition, if
 needed. Maintain and regularly update file on market prices for commonly purchased items.
- In coordination with the program staff, ensure that all purchases on Activities / Grants fall within the approved budgeted amounts, or take appropriate action with the program staff prior to completing procurement.
- Develop and maintaining professional communication with all suppliers; keep record of all key suppliers, and regularly update vendor lists.
- Following up on the timely delivery, and coordinate with the Logistics Department on the receipt and delivery of all materials.



- Support timely procurement actions, including accuracy of invoices, and submission of all necessary procurement documents to the Finance Department. This includes Invoices, complete procurement documentation (including all bidding documents and Contracts / POs), Waybills, etc.
- Develop, update, and maintain Procurement tracking systems of all Purchase Requests by maintaining PR master list.
- Ensure proper use of procurement paperwork including Purchase Request, Request for Quotations, Quotes, Purchase Order, Bid Analysis.
- Orient all DT Global South Sudan / Shejeh Salam employees to Procurement procedures under the direction of the Procurement Director.
- Enforce proper use of procurement ceilings and approval procedures.
- Coordinate with the Finance Unit to ensure that payments to vendors are made on-time and without any unnecessary strain on the financial systems of DT Global South Sudan / Shejeh Salam, in cooperation with the Procurement Director
- Ensure that all DT Global South Sudan / Shejeh Salam procurement activities are legal and ethical.
- Ensure compliance with established DT Global South Sudan / Shejeh Salam and USAID, as well
 as South Sudanese laws, all financial management rules and procedures for all procurements.
- Supervise other procurement staff as delegated by the Procurement Director and Deputy Chief of Party for Operations and Finance.
