Submissions should include valid <u>registration and operation documents</u> i.e.

- a. Certificate of Incorporation from the Ministry of Justice including the renewal stamps.
- b. Membership Certificate
- c. Tax Identification Certificate
- d. Tax Clearance Certificate
- e. Operation Licence from the State Ministry of Finance & Economic Development
- f. Shipping License from the Ministry of Transport, Directorate of River Transport

Tenderers shall in the Tender Submission Form attest that they meet the above eligibility criteria (valid registration and operation documents). If required by the Contracting Authority, the accepted Tenderer shall further provide evidence satisfactory to the Contracting Authority of its eligibility through certificates issued by competent authorities in its country of establishment or operation, or, if such certificates are not available, through a sworn statement.

Tenderers shall also be requested to certify that they comply with article 13. "Child Labour & Forced Labour" and article 14. "Mines" of the General Terms and Conditions for Supply Contracts.

To give evidence of their capability and adequate resources Tenderers shall provide the information and the documents requested in the Tender Dossier.
