### **Key responsibilities**

- Work in partnership with and provide technical guidance, oversight and support to Titi Foundation and CARE South Sudan GBV/Protection staff and local women-led CSO partner.
- Design the research tool and provide guidance on the establish research protocols, data collection tools, which may be either an adapted version of CARE's RGA or an accepted inter-agency methodology.
- Review the Establish relevant research protocols for key informants who may have challenges with Internet connections in the study areas as mapped out by Titi Foundation.
- Ensure that methodologies and protocols for ethical and sound data collection, analysis, storage and sharing of GBV data are established in accordance with GBV IMS and agreed GBV Information Sharing Protocol.
- Facilitate training with support from CARE SS to Titi Foundation staff and enumerators on research
  and analysis methodologies and provide support to the assessment team during data and information
  collection.
- Support Titi Foundation with Analysis and synthesis of data and findings and drafting of policy study report.
