Expected Deliverables:

- a) Audited Financial Statements of the Organization including Auditor's opinion there on.
- b) Management letter highlighting Financial Management and Internal Control issues noted during the audit together with Auditor's suggestions and recommendations.

Audit Firm Experience and Qualifications:

Firms will be required to meet the following criteria.

- e) The CVs of key staff proposed for the assignment.
- f) Proof of registration with a regulating body and partners current practising certificate.
- g) Financial proposal detailing the proposed fees / or expenses in USD. The Financial Proposal should be separated from the Technical Proposal.
