## Purpose of the position:

The Food Security & Livelihoods (FSL) Assistant will be assisting the implementation of the FSL project funded by FAO in Juba (Kator & Rajaf Payam). The FSL assistant will provide technical support required to the team and extension workers through supervision, management and reporting of the project progress. Liaise with the FSL officer for any field activity or challenge that may arise during the project implementation process. He/She will be implementing FSL related trainings, monitoring and reporting of project activities, and work closely with chiefs/quarter council of the/Payam/blocks.

## Major Roles and Responsibilities

- Ensure Community mobilization, beneficiaries' identification and registration
- Take a lead to mobilize community leaders and other community-based stakeholders and explain the objectives of the project
- Facilitate the process of formation of Accountability for the Affected Population (AAP) and engage them in developing beneficiaries' selection criteria
- Mobilize the community members, through the AAP and local authorities for initial briefing and beneficiaries' registration
- Conduct registration of beneficiaries through selected members of the AAP
- Compile and organize beneficiary lists and share with the FSLO Inputs distribution and trainings



- Take in lead in planning and implementing the whole distribution process
- Conduct a safety audit and selection of distribution sites with the community leaders.to ensure that distribution sites are protected with ample space, shade and water source
- Ensure that livelihood inputs are delivered to the distribution sites timely
- Ensure timely distribution of the inputs (starts early and ends
- Prepare order requests for project related requirement necessary to programme implementation, with support from FSL Manager and the Procurement/Logistic Officer.
- Conduct capacity assessment for the Agricultural Extension Workers before they are engaged into community's related work.
- Work with Extension workers through the guidance of the officer to set up home gardening with the beneficiaries.
- Participate in training of market vendors on vegetable post-harvest handling and marketing
- Conduct awareness campaigns to promote good practices (in markets and through radio programming) on COVID-19 safety rules and regulations
- Conduct awareness on the risk of COVID-19, transmission and mitigation along the supply chain
- Ensure proper utilization of project resources through transparent management and reporting; ensure all financial supporting documents are in place for all transactions.
- Preparation of daily, weekly, quarterly and final reports, as required;
- Document success stories from the project, with support from the FSL Manager

## Qualifications: Education/Knowledge/Technical Skills and Experience

The following may be acquired through a combination of formal or self-education, prior experience or on-the-job training:

- Diploma in agriculture/crop production. Experience of implementing similar projects as well as
  experience in community mobilization, targeting, crop demonstration, vegetable production,
  other agronomic practices. Experience in VSLA (Voluntary saving and lending association)
  including entrepreneur skill development.
- Minimum 3 years' experience as project assistant officer or other similar position in food security and livelihood area.
- Knowledge and experience from among the following skill sets is desirable: Farmer
  Demonstration, community-led participatory planning, women's and youth economic
  empowerment and leadership development; savings groups/rural finance, local value chain
  development/market systems development; seed multiplication, horticulture, post-harvest
  management, community-led peacebuilding
- Proven abilities in managing successful community-based projects;
- Energetic and motivated skills in community mobilization, training, and team-building;
- Proven analytical, problem-solving skills and comfortable working under minimal supervision;
- Highly organized, efficient, and able to meet key deadlines;
