#### **Pricing Options:**

Bidders must provide price quotations according to one of the following options:

- For vehicles imported into South Sudan, tax exemption applies. Prices quoted should include delivery to the ZOA Dorcas
  office in Hamza Inn, Old Juba City, South Sudan, excluding all duties and import taxes as per the Republic of South
  Sudan National Directorate of Taxation Act.
- Tax exemption applies to the vehicle itself, excluding all applicable government taxes as per the Republic of South Sudan National Directorate of Taxation Act. Additionally, transportation and delivery costs to the ZOA Dorcas office in Hamza Inn, Old Juba City, South Sudan, should be covered in the quoted price.
- The successful bidder is responsible for covering all handling and transport costs from the supplier/manufacturer's location to the ZOA Dorcas office in Juba.
- · All prices must be quoted in USD.

#### Validity:

Bids shall remain valid for a minimum of 90 calendar days after the bid closing date. By submitting the Bid, the Bidder affirms that it provides an irrevocable offer for the specified duration.
