Consultancy Terms of Reference (ToR)

Review of Integration of Young Mothers in the Education System in South Sudan

1. Background

Plan International with support from UNICEF and Education Cannot Wait (ECW) are collaborating on a project aimed at improving the educational opportunities and integration of young mothers in the education system in South Sudan. The country has faced prolonged conflicts, economic instability, and cultural challenges, which have adversely affected the education system, particularly for young mothers. This review aims to assess the current state of integration of young mothers in the education system, identify barriers, opportunities and recommend strategies for improvement.

It is with this background that PISSD plans to conduct a country-specific review on the integration of young mothers in the education system with a specific focus in locations where the MYRP2 is implemented. This will need the services of a consultant who will conduct the review and compile recommendations for improving the integration of young mothers and share findings with relevant stakeholders.

2. Objectives:

This is a study that specifically looks at young mothers coming back to education in SSD looking at the barriers and opportunities for their access to the education system in the Multi-Year Resilience Project that is supported by ECW is being implemented. Challenges will be assessed, and recommendations made for improved reintegration of young mothers in the education system in the country.

The primary objectives of this review are:

- 1. To assess the current status of young mothers in the education system in South Sudan.
- 2. To identify the key barriers and challenges that young mothers face in accessing and continuing their education.
- 3. To evaluate the effectiveness of existing policies and programs aimed at integrating young mothers into the education system.
- 4. To provide recommendations for improving the integration of young mothers in education.
- 5. To share the findings and recommendations with relevant stakeholders, including policymakers, educational institutions, and non-governmental organizations (NGOs).

3. Scope of Work

The review will cover the following areas:

- Desk review of existing literature, policies, and data.
- Conduct qualitative and quantitative research through surveys, interviews, and focus group discussions with young mothers, educators, school administrators, and policymakers. Identify case studies of successful integration of young mothers in education.
- Identify socio-cultural, economic, and institutional barriers that prevent young mothers from accessing and continuing their education.
- Assess the impact of conflict and displacement on the education of young mothers.
- Evaluate the effectiveness of current policies and programs designed to support the education of young mothers and Identify gaps and areas for improvement.
- Provide actionable recommendations for improving the integration of young mothers in the education system. Develop a strategic plan for implementing the recommendations.
- Engage with relevant stakeholders throughout the review process.
- Organize workshops and meetings to share findings and recommendations.



4. Methodology

The review of the young mothers return to school program will employ a mixed-methods approach, including: desk research, surveys, interviews, FGDs and case studies.

5. Deliverables

- Inception report with a detailed work plan and methodology, including data collection tools
- · Summary of findings from the desk research
- Analysis of data collected from surveys, interviews, and focus group discussions. This will include evaluation
 of existing policies and programs.
- Comprehensive report with findings, conclusions, and recommendations will be shared for review by the client (PISSD) and finally a validation workshop -Presentation of findings and recommendations to stakeholders.
- **6. Timeline:** Approximately 20 working days between Mid-September October 2024 From opportunity advert to completion of sharing findings with other education stakeholders. The consultant will develop a clear work plan with timelines as agreed with the client (PISSD).

8. Ethics and Confidentiality

The review will adhere to ethical standards, ensuring the confidentiality and privacy of all participants. Informed consent will be obtained from all participants, and data will be handled with the utmost care and confidentiality.

9. Qualifications of the Successful Consultancy Firm

a. Academic Qualifications:

- A consultancy team/person with gender and education expertise, human rights expertise and a Monitoring, Evaluation and Research expertise will be prioritized.
- The team/person should possess post graduate degrees in Project Management, Social Sciences, Development Studies, Public Policy, Economics, Gender Studies, Human Rights or related discipline.
- Advanced university degree (Master's degree or equivalent) in a field relevant to the assignment, for example in gender studies, social sciences, education studies, development studies or equivalent.

b. Professional experience:

- Minimum of ten (10) years professional experience in social development, gender analysis, project management and a very good understanding of project/programme development.
- Specific proven experience and expertise in conducting gender analysis, education and gender related studies, preferably in emergency settings/humanitarian response, and empowerment and girls and boys participation;
- Extensive experience working on national gender policies in developing and humanitarian countries;
 Familiarity with the South Sudan context and education system is essential, other field experience being desirable;
- Knowledge of international/regional frameworks on gender and inclusion such as SDGs, CEDAW, Beijing Platform, etc.;
- Demonstrated experience in programmes related to mainly Education, Gender equality, disability inclusion, Child Protection, Gender Based Violence and women's empowerment.

c. Competencies:

 Prior demonstrated experience in developing programmes for humanitarian and development partners within a developing country context.

Extensive knowledge on gender analysis, gender M&E framework and action plan development and gender mainstreaming into projects and programs.

- General knowledge of gender transformative approach with substantial experience in project design, implementation, monitoring and evaluation
- Excellent research, analytical, and report writing skills.

Language and other skills:

- Excellent knowledge of English, including the ability to set out a coherent argument in presentations and group interactions; Arabic will be an added advantage
- Excellent research, analytical skills and strong oral and written communication skills: Capacity to communicate fluently with different stakeholders (development partners, government authorities, local communities, project staff); and reflect results in comprehensive report
- Computer skills: full command of Microsoft applications (Word, Excel, PowerPoint) and common internet applications will be required.
- Ability to work independently and meet deadlines.

10. Safeguarding Children and Program Participant Policy

Plan International is committed to actively safeguarding children and program participants from harm and ensuring children's rights to protection are fully realized. Plan takes seriously the commitment to promote childsafe practices and protect from harm, abuse, neglect and any form of exploitation as they come into contact with Plan International-supported interventions. In addition, we will take positive action to prevent child abusers from becoming involved with Plan International in any way and take stringent measures against any Plan International Staff and/or Associate who abuses a child or program participant. Decisions and actions in response to safeguarding concerns will be guided by the principle of 'the best interests of the child.'

The Integration of young mothers in education systems review will involve conducting interviews with children, also adolescents exploring sensitive topics, such as sexual gender-based violence. The study must, therefore, ensure appropriate, safe, non-discriminatory participation; a process of free and un-coerced consent and withdrawal; confidentiality and anonymity of participants. Environments and working methods should be adapted to the capacities of adolescents; time and resources should be made available to ensure that adolescent girls and boys are adequately prepared and have the confidence and opportunity to contribute their views.

Consultants are required to provide a statement within their proposal on how they will adhere to the abovementioned policies, including how they will ensure ethics and protection of adolescents in the different stages of the study — including recruitment and training of enumerators.1, data collection and analysis, visits and report writing — in line with Plan International's Gender Equality and Inclusion Policy and Safeguarding children and program participant Policy. This must also consider any risks related to the study and how these will be mitigated. Consideration must be given to:

- Safeguards to protect the confidentiality of those participating in the study.
- Data protection and secure maintenance procedures for personal information

Caregivers' consent concerning data collection from adolescents and collation of data about adolescents. Age-appropriate assent processes.
