Organizational Background

Position Description

This position is for the MOMENTUM Integrated Health Resilience Project (MIHR) in South Sudan, implemented by IMA World Health, with JSI Research & Training Institute, Inc., GOAL USA Fund, and Pathfinder International. MIHR South Sudan aims to support improved MNCH/FP outcomes and strengthen the USAID/South Sudan resilience platform. The Community Service Delivery Advisor for South Sudan MIHR will provide leadership and management oversight to the community activities of the project. The position will be based in Juba, South Sudan and will report to the COP, with guidance from HQ Core technical staff. This position is contingent upon funder approval and availability of funds.

Key Responsibilities

- Provide technical leadership and guidance in coordination and provision of quality user-centered integrated FP/RH/MNCH community service delivery
- Provide technical support to the national MOH for improved programming and scale-up of iCCM and the Boma Health Initiative (BHI)
- Provide technical support to strengthen national iCCM guidelines
 - o Contribute to technical reviews of national iCCM guidelines and standardized data collection and management tools
 - o Identify and address gaps in iCCM guidelines (e.g., integration of nutrition and other MNCH/FP activities)
 - Co-facilitate dissemination meetings to promote awareness and dissemination of the updated national iCCM guidelines and tools
 - Support the MOH at the national level to "translate" updated national iCCM guidelines into a summary document/job aid for use at the county and community levels

- Provide technical support to the integration of FP/RH/MNCH community based services as BHI expands beyond iCCM to FP/RH and other MNCH services
- Coordinate with SBC/Gender Advisor to design community service delivery activities in response to findings from MIHR Social Norms and other community-based studies
- Provide input to the development of technical activities for annual work plans, studies, quarterly and annual reports, financial reports, and other reports and papers
- Support learning and research activities
- Support ongoing efforts of partners and MOH to adapt the Reaching Every District/Child (RED/REC) strategy in under-performing districts to revitalize and/or sustain routine immunization coverage, which is being further threatened by the ongoing COVID-19 pandemic
- Participate in national technical working groups (TWG) supporting the MOH in establishing priorities, leveraging resources, strengthening partner coordination and improving FP/RH/MNCH and immunization outcomes
 - Provide capacity building support to strengthen the TWGs
 - Participate in workshop(s) for the development national strategies and guidelines
- Provide technical guidance to the County Field Coordinators, Community Strengthening Liaisons, and FP/RH/MNCH Officers

 - Master's Degree in public health or a related field; Degree with 8 years of relevant experience will be accepted in lieu of a Master's Degree
- Experience:
 - Four years of relevant experience working on MNCH/FP/RH programs of similar nature, size, and complexity, with national or local governments, NGOs, or donors

 - o Experience with service delivery indicators in MNCH/FP/RH
 - Experience in routine immunizations in vaccine delivery, for example micro planning with the RED/RED strategy, organize SIAs like child health days, measles and polio campaigns.
 - Experience in community health integration IMCI and iCCM in a primary health care approach to reach universal immunization services and contribute to UHC.
