


#### **VACANCY ANNOUNCEMENT**



Action Against Hunger USA is currently looking for a qualified <u>South Sudanese Nationals</u> to fill in the position of <u>Wash Hygiene Promoter-Juba</u> -02 positions

Position open date: June 29th, 2020.

Closing date: July 05th, 2020.

Expected Start date: Immediately.

Contract Duration: 6 Months.

Location: Juba.

#### **TASK & RESPONSIBILITIES**

The WASH Hygiene Promoter ensures that water, sanitation, and hygiene and Covid-19 awareness, are implemented effectively, professionally, and in accordance with the culture and practices of the local population.

#### **Objective 1: Undertake Community Mobilization**

- The Hygiene Promoter has key activities & responsibilities to achieve this objective:
- Meeting with local leaders and community elders to communicate the details of overall ACF program objectives and specific WASH program objectives
- Organizing Community meetings to discuss and communicate details of specific projects
- Assessment and selection of Communities for implementation of PHAST methodology together with WaSH Officer/Program Manager.
- Identify beneficiaries for the program from target Communities.

# Objective 2: Organize Health and Hygiene Promotion Campaigns

- Organize health and hygiene campaigns in selected schools including, but not exclusive to, activities like; Hygiene Education Games, Poster competitions, Street/interactive theatre, Singing competitions, Hygiene Promotion Rally's, Hand Washing Demonstrations and Toilet Use Demonstrations. Separate activities are to be organized for girls and boys when necessary.
- Organize health and hygiene campaigns in selected Communities and undertake activities including; Community Hygiene promotion meetings, Interactive theatre, transect walks, community mapping, Hand washing demonstrations, household latrine promotions, water handling trainings, household water treatment demonstrations and Oral Rehydration Therapy demonstrations.

#### Objective 3: Formation and organizing trainings for community level institutions

- Formation/ reactivation of Community Committees in areas of operation of the WASH team
- Mobilizing community contributions for the construction activities like sand, gravel, labour etc.
- Organizing training for Community Committees and Care Takers in coordination with the WASH Officer and Program Manager.
- Formation and training of hygiene clubs

#### Objective 4: Participate in surveys and other monitoring exercises

- Participate in KAP surveys and other survey exercises organized by WASH and other departments on the request of the Program Manager
- Assist in data collection for monitoring of water points and other projects according to the monitoring schedule available
- Familiarize with the data collection formats created as part of the project and use them accordingly

# Objective 5: Collaborate with FSL and Nutrition department staff in integrating WASH components into their programs and vice versa.

- Organize and participate in community mobilization and hygiene promotion activities related to Nutrition and FSL team activities
- Collaborate with CNV's and Community extension workers to organize hygiene promotion activities for Nutrition and FSL beneficiaries in coordination with respective teams, under the guidance of the Hygiene supervisor.

### **Objective 6: Planning and Reporting**

- Create weekly action plans under the supervision of WaSH Officer/Program Manager
- Maintain daily diaries on activities Participate in weekly staff meetings and submit weekly reports to WaSH Officer on every Friday of the week.
- Supporting the Data Clerk and WaSH Officer to collect the data on number of beneficiaries, activity done and other essential data.

# Objective 7: To organize and implement Emergency response for WASH needs

- ❖ To Travel and activity participate on implementation of emergency hygiene promotion in place where assigned by Manager.
- To assess the WASH needs for IDPs or refuges according to the guideline from the supervisor.
- Support the other ACF bases in case of emergency needs
