

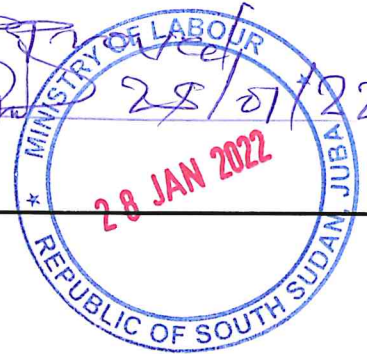

### ORGANIZATIONAL BACKGROUND

### POSITION DESCRIPTION

**This position for the MOMENTUM Integrated Health Resilience (MIHR) project, led by IMA World Health, the post will report to the County Project Officer, based at the County Health Department.**

Under the guidance and close supervision of the County Project Officer and with technical support of the MNCH Advisor and Services Strengthening Advisor, the FP/RH/MNCH Officer is principally responsible for implementation of all FP/RH/MNCH related activities in the MIHR supported health facility. S/he is the MIHR focal person for RH/MNCH services delivery and work in collaboration with other health providers, prepare and submit report on weekly and monthly

### **Duties and Responsibilities**

- Perform routine antenatal checks and identify any risks to the mother or infant.
- Provide information about family planning.
- Coach new mothers on how to breastfeed and bathe newborns.
- Guide mothers through childbirth before and during labor.
- Record the client details in the MoH respective registers
- Counsel expectant mothers on birthing plans, including hospital care, birthing centers, and other options
- Provide emotional care for mothers during birth
- Arrange prenatal planning and care for mothers
- Prepare for birthing by following all health and safety standard
- Coach mother through the birthing process



Perform deliveries and assist caesareans where is applicable.

- Assist surgeons and physicians in caring for the mother during complicated births.
- Provide care for mothers and newborns after birth including post-partum family planning services.
- Weigh and measure newborns
- Monitor the patient's vital signs and heart rate during birth.
- Study patient history and health assessments
- Communicate stages of birth to family members.
- Explain and demonstrate breastfeeding techniques to mothers.
- Monitor patient postpartum and be available for questions or concerns.
- Perform CPR or other emergency measures if needed.
- Participate in the immunization of children and women of reproductive health age.
- Compile weekly and monthly summary report on ANC, Deliveries, PNC and immunization and submit to the County Project Officer for further sharing with MIHR M&E team.
- In collaboration with MNCH units In-charges, compile and submit monthly reports to CHD.
- Attend continuous professional development (CPD) sessions training and workshops.
- Conduct weekly RH commodities stock take and notify the CPO every Friday evening.
- Respond/call integrated call center (ICC) on toll free 229 to give feedback on RH commodities stock and services delivery.
- Ensure adherence to Covid-19 Protocols during care provision.
- Perform any duty as assigned by the Supervisor.

### **REQUIREMENTS**

- Nurse or clinical officer with experience as a family planning provider
- Hands on experience in a setting that provides FP/RH care (e.g. post-abortion care, IUD services)
- Must have at least five years of experience in a clinical setting

### **Attitudes**

- ✚ Proactive, takes initiative and flexibility.
- ✚ Reporting experience, problem solving and diplomatic skills.
- ✚ Respect when dealing with others and presentable, outgoing with a pleasant character.
