The senior field monitor will be working closely with the Third-Party Monitoring and verification (TPM) manager to lead the team, organizing its work, and ensuring high quality control and submitting deliverables acceptable to USAID standards. The senior field monitor will be responsible for monitoring project level activities and contextual indicators and assessments, timely project monitoring and assessment reports. The senior field monitor will be responsible for designing implementing and reporting monitoring activities including activities planned for rapid assessment. The senior field monitor will also collaborate with USAID/South Sudan's program office and technical teams; MSI's technical teams, implementing partners' (IPs) project teams; local community members; and government officials at state and county levels.

Responsibilities:

- Actively contribute to fine-tuning of third-party monitoring, inspection, and rapid assessment procedures.
- Monitor and verify all implementing partners' project plans, activities, and progress towards achieving project outputs including monitoring conflict triggers and analyzing context in which projects operate.
- Monitor and assess overall progress on achievements of results, including access, availability of services and products.
- Monitor and report on Do-No-Harm principle of USAID-funded activities.
- · Monitor sustainability of project results.
- Provide feedback of the monitoring and verification findings to technical teams, USAID project COR/AORs.

- Suggest strategies to IPs project team, USAID project COR/AORs for improving efficiency and
 effectiveness by identifying bottlenecks in completing project activities developing plans to at least
 minimize such bottlenecks.
- Prepare monitoring reports and project activities and report to TPM manager. OF S
- Observe and verify soft and hard activities in the field using technology-based data collection techniques.
- Collect GPS-stamped photographs, GPS coordinates and other verification related media as security and policy allows.
- Coordinate and conduct site visits, which may include remote monitoring.
- Assess the implementing partner's progress against timelines and benchmarks in implementation/work plans.
- Conduct checks of the timeliness and quality of activity inputs and outputs.
- Confirm the accuracy of data reported by partners in the quarterly and annual reports.
- Verify compliance issues at project sites gender, branding and environment.
- · Participate in reviewing draft monitoring reports by the Field Monitors.
- Complete and multi-task by establishing priorities while taking into considerations special assignments, changing priorities, frequent interruptions, available resources and deadlines.
- Establish, build and maintain effective relationships with staff and clients to facilitate the provision
 of monitoring support.

- At least three (3) years of experience monitoring and/or implementing development projects.
