SSUHA seeks to invite interested and eligible bidders to submit sealed & stamped bids for a Full Contract of the **CONSTRUCTION OF RAIN WATER HARVEST, WASTE PITS AND VIP LATRINES AT HEALTH FACILITIES IN GREATER YEI, LAINYA AND MOROBO COUNTIES, YEI RIVER STATE, REPUBLIC OF SOUTH SUDAN.**

A sealed envelope marked "Bid Tender" carrying the Bidder's bid documents should be included in the envelope carrying the original documents. No bid security in the form of cash or otherwise will be accepted and will lead to automatic disqualifications of the bidder. All sealed and stamped bids should be submitted to **SSUHA** offices in Juba and Yei.
4. **Essential (inclusion) Criteria:**
 - Relevant & Valid licenses to operate in South Sudan.
 - Bidding companies must hold licenses such as certificate of competence.
 - Bidding companies must hold complete profile of the company
 - Tax clearance certificate
5. The selection criteria: **Technical** and **Financial**
 - TECHNICAL CRITERIA [minimum requirement] will be carried out based on the following:
 - A. Bidding companies shall attach previous works performance letter from Government, NNGO, or NGO in similar types of work.

- B. Adequate and elaborated work plan (Implementation plan).
- C. Proposed Methodology for the work in this bid document.

A. Bidder shall attach latest bank statements preferable for three (3) months.
