Terms of Reference

For a Consultant to Implement Business Start-Up Trainings for Caritas Torit, Catholic Diocese of Torit and Caritas Yei, Catholic Diocese of Yei

1. Introduction

Caritas, the Social wing of the catholic dioceses of Torit and Yei are implementing a consortium project called PEACEFUL, Promoting Ecosystems and Communities for Enhanced Livelihoods through understanding and Learning, adapted to the Humanitarian, Development and Peace nexus, with keen interest in the restoration of livelihoods, preserving natural resources while mitigating conflicts within natural resource management peacefully among returnee and host communities in the target counties.

The consortium includes Caritas Switzerland as the consortium lead, Caritas Torit, Caritas Yei, Justice and Peace Commission (JPC) and Organic Farming Advisory Organization (OFAO) as the implementing partners of the PEACEFUL project.

The project targets returnees and host communities in the counties of Torit, Magwi and Yei with a prospect to diversify and identify income opportunities that will support farmers and small-scale business holders with improved market access and enhance income generation activities among communities. The projects aims at creating opportunities that will increase and alleviate income generation with a sense to environment sensitivity while utilizing locally available skills, knowledge and resources to thrive while creating employment opportunities within the local markets.

The project plans to provide through utilizing of farm inputs through existing market producers and suppliers in order to create sustainable linkages and to reduce the dependence of the communities on external sources. Linkages to local agro-dealers, traders and Village Savings and Loan Associations (VSLAs) incorporated into the shall support the farmers and small scale business holders in optimizing the markets for their produce.

In order to support inclusive and sustainable businesses, the project targets to train 440 youth , women and farmers across the counties Torit, Magwi and Yei in business idea development while support 70 successful business plans with grants of which the 50% is paid back as revolving loans to ensure sustainability of businesses. The business can either be in group or individual proprietorship.

Caritas Torit and Caritas Yei are therefore seeking to hire a consultant or a consulting company to off these service with the deliverables below,

2. Expected deliverables of the consultant

- 1. Consultant will lead a 2-day **Business Idea Development Training** (ca. 20-30 candidates per training/boma)
- 2. Participate in the pitching/selection of submitted business plans of the trainees
- 3. Lead a 3-day **In-Depth Business Start-Up Training** for selected businesses who will receive grants and revolving loans (per county)
- 4. Provide training certificates to successful business plans

3. Duration, Place of Execution and Methodology

The consultancy shall be conducted between **February** -March 2024 and shall have a duration of a <u>maximum 50 days including reporting</u>. The consultant is expected to travel to the project locations (in the project.

Caritas Yei and or Caritas Torit, depending on the locations will be responsible for,

- Provision of relevant project and context documents;
- Guidance throughout the process;
- Logistical arrangements for all field travels, accommodation and feeding
- Key background resources identification
- Facilitation with required key stakeholders

The consultant will be responsible for:

- Review of documents
- Regular progress reporting to the Executives Director or project activity lead, including responding to any comments or technical inputs;
- Production of deliverables within agreed timeline and in accordance with standard quality requirements;
- The Consultant will be required to abide by local security procedures and rules in place for staff. CACH will however offer security briefing at inception of the activities.

4. Consultant Skills Requirements

The Consultant must meet the following requirements:

- University degree in a relevant field (Economics, Entrepreneurship and Business management, Agricultural Economics, Rural Development, and or related field)
- At least 4 years professional working experience in the field consultancy with additional at least 5 years of hands on project implementation in the relevant field and organization/companies

- Proven strong experience in implementing Business Start-Up Trainings, business plan development, fostering of inclusive and sustainable value chains. Added value is work experience with female entrepreneurs and illiterate / semi-illiterate business holders.
- Experience in setting up small-scale businesses/informal businesses in rural, conflict-affected areas
- Excellent writing skills
- Proven experience of cooperating with people from different cultures. Sensitivity for political, social, intercultural and security issues.
- Analytical thinking and openness for innovative solutions
- Fluency in English. Ability to speak local dialects and Arabic will be an asset
- Experiences of working under volatile circumstances and flexibility to cope with operational challenges

5. Technical and Financial Offer

Submitted bid documents have to fully comply with this Terms of Reference (TOR) and must contain a technical and a financial section.

The technical proposal shall include:

- Up-to-date CV detailing the consultant's profile and relevant experience
- Work plan outlining which activities will be conducted and how many working days are required for each activity.

The financial offer shall include the proposed consultancy rate per day in USD (including all costs related to the consultancy).
