BACKGROUND/INTRODUCTION

Islamic Relief South Sudan received funding from IRUSA to implement a 3 years' development project in Yei and Kajokeji county focusing mainly on three thematic areas of FSL, WASH & Protection. The project's goal is to secure smallholder farmer's livelihoods and resilience in the context of sustainable development. The proposed project will address food insecurity through economic strengthening interventions and other livelihood strategies that help vulnerable communities, mainly smallholder farmers in Yei and Kajo keji counties, who have been affected by the recurrent conflict and severe food shortage.

The Project intends to address the Food Security & Livelihoods and WASH needs of the conflict affected food insecure vulnerable smallholder farmers in Yei and Kajo keji Counties of South Sudan and estimated 10,000 persons will be reached by the proposed interventions which will aim at

- Increased resilient livelihood opportunities through enhancing agricultural productivity, availability and consumption of diversified food to conflict affected food insecure vulnerable small holder farmers;
- Improved contribution to and influence of conflict affected smallholder women farmers over income and decision-making
- Improved access to safe water and sustainable use of water facilities for the targeted conflict affected communities.

Therefore with this ToR, the project intends to procure assorted farm tools (460 Yei and 460 Kajokeji) as highlighted in the below section.
