# DEPARTMENT/COUNTRY PROGRAM DESCRIPTION/MISSION

The overall objective of ALIGHT program is to prevent death and alleviate human suffering among displaced persons (DPs) in settlements and host communities where we work. ALIGHT has embarked on WASH, provision of Shelter, construction of facilities and Camp Management activities in Wedweil Refugee Transit Center in Aweil West County. ALIGHT is taking a multi-sectoral approach in responding to the displaced persons' needs and is integrating nutrition into its current interventions.

## PRIMARY PURPOSE OF THE POSITION

The purpose of the F WASH/CIVIL Engineer position is to provide the on-site supervision to ALIGHT planned activities in Wedweil Refugee Transit Center and outlying settlements and any other part of the Country. Under supervision of Program Manager, the Engineer will:

- Manage and monitor construction of appropriate water and sanitation facilities, shelter and settlement units and other facilities within and outside the Center including development of architectural / engineering designs and BoQs,
- Design, manage and coordinate construction or activities related to provision of sanitation services to the displaced persons.
- Manage the planned activities in coordination with, camp management coordinator, the government, and local partners,
- Develop work plans in coordination with other Program and Operations units in Aweil West and other project areas.
- In consultation with the Program Manager, manage the budget of the WASH, shelter, and Settlements sections of the programs at field level.

- Design and supervision of construction or rehabilitation works in and outside the center.
- Collaboration, planning and coordination with UNHCR, Relevant Government Ministries and partners towards meeting the water and sanitation, shelter and settlements and associated facilities needs for the displaced and host community.
- Implementation of projects in accordance with ALIGHT Program Development and Implementation Guidelines
- Work with UNHCR, relevant Ministry staff and partners to establish operation and maintenance regime to ensure sustainability of the facilities constructed.
- Ensure optimal utilization of resources, cost effectiveness and accountability on site.
- Compilation and submission of comprehensive and accurate reports (weekly, monthly, quarterly) within the set deadlines.
- Consistent budget monitoring and program spending forecasts for finance unit

### **Technical oversight**

Ensure quality construction of all water and sanitation assets, Shelter and settlements units
and other facilities ensuring good maintenance and sustainable processes are put in place.

- Identify gaps and recommend appropriate corrective measures on infrastructure designs in the project sites.
- Assist the team in surveys, assessments, designs including on-site technical supervision.
- Review and validate as-built drawings/BOQs for all planned constructions and rehabilitations.
- Take lead in timely preparation and submission of project progress reports.
- Participate in project beneficiary characterization and mapping.

 Timely submission of monthly reports on achievements as per work plan submitted through the ALIGHT country office activities plan.

 Supervise the implementation of the entire infrastructure and prepare completion certificates.
