Description of Works/Service

ACROSS invites prospective vendors to submit bids for the provision of internet services to its offices and Guest houses in Juba as specified in the table below.

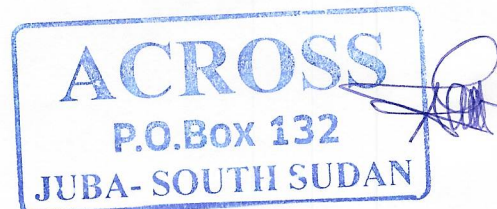

Documents to be submitted

Please ensure your tender submission is accompanied by the documents listed below and in the same order of appearance. Failure to provide any of this will result in automatic disqualification.

Tenderers' Eligibility and Qualifications.



The tenderer shall furnish, as part of its tender documents its qualifications to perform the contract if its tender is accepted. The documentary evidence of the tenderer's qualifications to perform the contract if its tender is accepted and that the tenderer has the financial and technical capability necessary to perform the contract.

#### Currencies.

All prices shall be quoted in USD

#### Submission of offer.

All potential suppliers are required to submit the bid documents in a sealed envelope. ONLY PHYSICAL SUBMISSION WILL BE CONSIDERED (HARD COPY). Any bid submitted electronically shall not be considered. Sealed bids should be clearly marked with the following tender reference number and delivered to the following address:

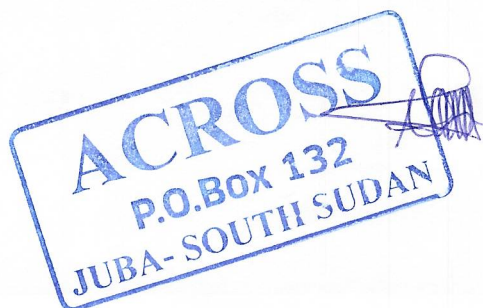

#### EVALUATION CRITERIA

##### Award Criteria.

When analysing the offers, ACROSS will take into consideration the following award criteria to achieve best value for money:

- Company profile, background, and expertise.
- Financial capacity.
- Technical expertise, knowledge and understanding of works required.
- Delivery timelines of works required.
- Evidence of similar works performed in a similar geographical location.
- Letter of reference from other International NGOs or reputable companies.



- Presence of onsite support in remote location/Technical support structure for remote locations. (This is a key priority and should be clearly explained)

Preliminary evaluation: Non-discretionary “PASS” or “FAIL” rating based on submission of the following documents.

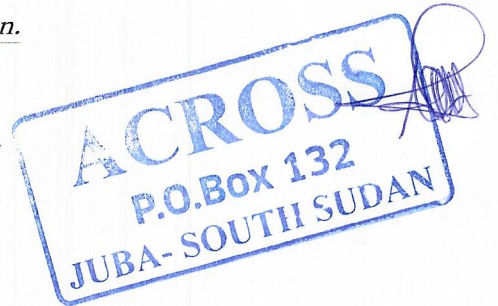
Mandatory requirements.

- Financial & technical proposal for works to be undertaken.
- Certificate of registration/Incorporation (Including a copy of the updated stamp)
- Revenue authority tax registration certificate indicating TIN.
- Valid tax Clearance Certificate.
- Valid operation/trading licence.
- Official business physical location, postal, telephone and email address.
- Reference and recommendations from at least 3 present and 3 past international NGOs that your firm/company has done business with them in the location of interest.

*NB: Only qualified bids shall be considered for the technical evaluation.*

Technical Evaluation

- ✓ Responsiveness and full compliance to technical specifications.
- ✓ Completeness of bid to the requirement.
- ✓ Currency of quotation USD.



Financial Evaluation

- ✓ Financial comparison of the technically qualified bids after arithmetic analysis and award to lowest priced bidder.
