The officer will ensure appropriate physical rehabilitation of target children with special educational needs, building resilience and education in emergencies for the most vulnerable populations. He/she shall ensure proper coordination with relevant stakeholders the include; Education cluster, authorities (both local and government), humanitarian actors, PTA's (Parents Teachers Association), and beneficiaries/associations advocating for Inclusive Education at both local and national levels.
