Knowledge, Attitude, Practices and Behaviour (KAPB) Survey Regarding WASH, SRH & IYCF Practices in Juba IDP Camps I & III.

Background and Context

IsraAiD and Camp Coordination and Camp Management (CCCM) work together to deliver humanitarian and lifesaving assistance programs in an accountable and effective manner in pursuit of their commonly-held charitable objectives. Our mission is to improve the quality of life of the most vulnerable groups through GBV, Health, WASH and Nutrition interventions and other related activities that build local capacity in the Juba IDP Camps I & III.

ISRAAID has been present in South Sudan since 2011 implementing GBV interventions. In August 2022, ISRAAID commenced working in the Juba IDP Camps I & III with an emergency response program focusing on enhancement of GBV prevention and SRH awareness for displaced populations. ISRAAID SSD secured funding in 2023 from ISRAAID HQ and Seed the Dream (STD) to expand emergency WASH interventions and continue a GBV prevention and SRH response program.

ISRAAID in South Sudan started a Community Based Protection Approach (CBPA), SRH, WASH and creation of a community based screening and referral for the nutrition program at Concern WorldWide (CWW) with both curative and preventive interventions to address the poor nutrition status of children, pregnant and lactating women. The integrated Health and Protection Project interventions started in August 2022 and aims at promoting, protecting and supporting community based resilience and GBV programming intervention services within the blocks practices. ISRAAID uses mass education, individual counseling, and community dialogues for SRH and GBV services. Our community based nutrition screening including MUAC screening will focus on improvement of Timed and Targeted Counseling for Health, WASH and Nutrition augmenting CWW's IYCF Counseling that focuses on the importance of early initiation of breastfeeding, exclusive breastfeeding up to six months of age, , timely introduction of complementary feeding for children 6-23 months old with continued breastfeeding up to two years and beyond, feeding of the sick child, good nutrition during pregnancy and lactation and improved hygiene practices. In addition, beneficiaries will be educated on a balanced diet, hygiene and sanitation, maternal and child health (MCH), cooking demonstration using local available food commodities and other caring practices to address the underlying causes of malnutrition.

This KAPB survey is intended to provide an understanding of the communities' level of knowledge, attitudes and practices on WASH, GBV, SRH, Maternal Infant and Young Child Nutrition (MIYCN); in Juba IDP Camps I & III and provide relevant recommendations that will inform and guide in tailoring community specific and appropriate innovative interventions in the area. The survey results and recommendations will also help the WASH, GBV, nutrition and health stakeholders to design appropriate behavior change and communication interventions.

PURPOSE OF THE TOR

The purpose of this TOR is to carry out an assessment to help IsraAID and other stakeholders understand the level of Knowledge, Attitudes, Practices and Behaviour (KAPBB) of the Juba IDP Camps I & III communities regarding WASH, SRH, Protection and nutrition practices and give relevant recommendations that will inform and guide appropriate design of interventions in the area.

GENERAL OBJECTIVE

The goal of the study is to evaluate how much the earlier interventions contributed to the increase in Knowledge, Attitudes, Practices and Behaviour and the influence this has had on behavior change of the communities regarding appropriate GBV, nutrition and WASH practices in Juba IDP Camps I & III. In addition the study findings will act as a baseline and the recommendations will aid in designing, planning and implementation of the future protection, health, WASH N" Nutrition interventions.

SPECIFIC OBJECTIVES

- Conduct a KAPB survey on WASH, GBV, SRH, Maternal Infant and Young Child Nutrition (MIYCN); Communicable Diseases
 especially those linked to hygiene and sanitation and other related factors such as health seeking behavior during illnesses;
- Use KAPB survey results to recommend key simple and achievable interventions that will address the identified issues to ensure appropriate practices;
- 3. To determine the effectiveness, relevance and appropriateness of the current BCC strategy (care groups, and others)

- Document cultural and traditional practices that enhance or undermine appropriate nutrition and hygiene practices in the two Juba IDP Camps;
- 5. To determine community knowledge and awareness on other protection, health, WASH N" Nutrition interventions.

METHODOLOGY

Using these Terms of Reference, the intended consultant will prepare both financial and technical proposals elucidating how they intend to conduct the survey. The consultant is expected to propose and design a suitable methodology for gathering information and delivering results. This is a social study and both qualitative and quantitative data will be generated.

Main Tasks of the consultant

- Submit a report which will include an interpretation of the tasks and methodologies which will be used in the KAPB study;
- II. Develop appropriate tools and instruments for gathering information:
- III. Present the KAPBB Methodology at WASH, HEALTH, GBV, IYCF TWG and Partners upon sharing with ISRAAID
- IV. Review appropriate documents (nutrition Survey reports, DHIS Reports etc.) relevant to the survey;
- V. Conduct KAPBB survey-Train data enumerators, ensure quality of data being collected
- VI. Undertake consultations with key stakeholders and conduct field data collection;
- VII. Process and analyze the data, write and submit a draft report of the survey;
- VIII. Present Preliminary findings at the County, and present the final findings at TWG's upon sharing with ISRAAID
- IX. Present the draft report of the findings in a stakeholder forum for comments and feedback
- X. Revise and submit a final copy of the survey report including recommendations to the International Medical Corps.

DELIVERABLES

Deliverables under this consultancy will include the following:

- A detailed report showing how the consultant seeks to undertake the study. The report will include a clear methodology and data collection tools, analysis reporting details and a detailed work plan. This will be presented 4 days after the signing of the contract
- Be present at Directorate of Research and Ethics (Protection, Nutrition & Health and respective TWG's for presentation of the KAPB methodology and final findings a draft report detailing the survey findings and recommendations 19 days after completion of data collection activities in the field.
- A final report 6 days after completion of the field activities. The final report shall be submitted as scheduled to the Programme coordinators, technical advisor, in both electronic versions, MS Word and MS Excel, and 3 printed hard copies.

DURATION AND TIME

The entire assignment including preparation of the study tools and protocols, recruitment and training of data collectors, field work, analysis of data and report writing is estimated to last 23 calendar days. The exercise is expected to commence On 4th December, 2023.

- Must be computer literate with unquestionable competence in analytical packages such as excel, SPSS, SMART Methodology, CSPro, STATA or SAS or any other relevant software
