POSITION DESCRIPTION

He/she will ensure the successful operation of the ESIR program in Kajo-Keji and Morobo Counties. The Health Coordinator will provide leadership for the County based team in Kajo-Keji and Morobo and assist in the strategic planning and decision for the team in strengthening a decentralized Health System in Kajo-Keji and Morobo as Primary responsibility is to support and build capacity of the County Health Department to improve delivery of basic health services in the County. He/she will be responsible for overall monitoring and evaluation, reporting data and expenditures to the Director of Programs as well as for direct support of the County support team.

DUTIES AND RESPONSIBILITIES:

As part of the ESIR Project management team at the County level, he/she will

- Provide overall direction and leadership in the implementation of the project activities as per the signed/updated project work plans and contract document /guidelines, including Budgets, DIP, HR management, Security and Procurement plans.
- Mentor, strengthen and build capacity of the local (Project) Health Worker including on-site supervision, appraisal and coordination of delivery of healthcare services.
- Establish and maintain an effective monitoring and evaluation system for the project, undertake periodic visit to the supported Health facilities and ensure that regular analysis of Health Data (HMIS), the quality of care and gaps /needs is done in coordination with the County Health Department/ MoH teams. Ensure that the information are used by the CHD/MoH for planning purposes

- Work closely with facility-based staff and SBC/Gender advisor to ensure quality of activities through the provision of regular feedback on activities through routine monitoring tools for continuous improvement
- Support rollout of SBC communication activities/messages with partners in response to COVID-19 and other shocks and stressors
- Provide input into regular and ad hoc technical reports for HQ, MIHR team or USAID, as required
- Liaise with the resilience team to ensure SBC and gender activities support resilient individuals, families, and communities
- Supervise CHWs and provide guidance and training to improve continuity of care
