We are looking for an External Auditing firm to Audit our Accounts and Financial Statements and establish the financial position and performance of our Organization.

The Audit firm must be registered, qualified, experienced, with good analytical skills, Good communication skills, paying attention to details with sound Judgement

Duties and Responsibilities of the Auditor:

Planning for the Audit processes

Briefing of the Management regarding the Audit Plan and Requirements

Assesses and inspect the Internal Control System

Assess the risks in the organization

Audit and investigate issues in the Organization

Explain and brief the Management about the audit findings and Make recommendations/ Solutions to the Management regarding the Audit Findings.

Audit period is from August 1, 2023 to May 31, 2024 that is 10 Months for one Project. But it will be audited in 2 (Two) Phases as per Calendar Year and submit two separate reports.

First Phase of the project Audit is covering expenses incurred in the period from August 1, 2023 to December 31, 2023 that is 5 Months. Final Audit report is prepared and presented in accordance to with ISA 800 and 805 as well as according to donor terms of reference on audit of the project.
