## **Bid Submission Requirements**

To participate in this ITB, bidders must ensure their proposals are comprehensive and aligned with the full tender documentation. Bidders should provide:

- **Pricing Structure**: Clear and itemized pricing for air transportation, including all associated costs
- **Flight Schedule and Delivery Timeline**: Proposed schedule from Juba to Pibor, including estimated delivery times.



- Capacity and Aircraft Specifications: Details of aircraft available, including cargo capacity and ability to handle specified goods safely.
- Experience and References: Information on relevant experience in air transport within South Sudan, particularly to remote areas like Pibor. Include at least two references from similar projects.
- **Compliance and Certifications**: Proof of compliance with South Sudan's aviation and safety regulations, along with any required certifications.

#### **Evaluation Criteria**

Bids will be evaluated based on the following criteria:

- **Cost-Effectiveness**: Competitive pricing with transparency in cost structure.
- Capacity and Equipment: Suitability of aircraft and capacity for the specified cargo.
- **Delivery Timeliness**: Ability to meet specified delivery timelines.
- **Experience and Reliability**: Proven experience and positive references in similar air transportation projects.
- **Safety and Risk Management**: Measures to ensure the safe handling and transportation of supplies.
