Main responsibilities:

- Ensure that School feeding is implemented in the targeted schools in line with the established guidelines.
- Provide technical guide / support to the food Security team on the integration of Nutrition in the Food Security projects in Juba.
- Participate in developing nutrition training modules for schools and communities.
- Ensure that anthropometric assessments of beneficiary households for malnutrition are conducted; and then following the referral pathways in an event of identifying a malnourished child.
- Training the key nutrition and healthy diet related topics on "food cooking – culinary demonstration" to the school children (to the Hygiene club and the Agricultural club); teachers and the farmer group at the community level.
- Organize, Mobilize and ensure active participation of the communities in project activities such as nutrition activities at Schools and community level.
- Organize nutrition awareness campaigns including commemoration of global events locally.
- Ensure that NUTRITION activities are integrated with other activities for the optimum benefit of the beneficiaries.
