PART 1 – BACKGROUND

This Part provides background information of Medair and this RFP.

1. 1 Medair overview

Medair is a Swiss-based international humanitarian organization dedicated to relieving human suffering in some of the world's most remote and devastated places. We reach people in underserved communities that have been damaged by natural disasters, conflicts and other forms of crisis. In doing so, we help people recover with dignity and develop skills to build a better future. Medair has been working in South Sudan since 1992 and is one of the most active humanitarian relief organisations in the country.

Medair is issuing this Request For Proposal to select a service provider for staff medical insurance as specified in Part 1.2 below. Successful Bidder(s) will be expected to enter into a formal contract with Medair.

Although the successful Bidder will become the service provider, this tender will not constitute an exclusive contract and, in the event, that the service provider cannot meet the stipulated lead time or specification then another service provider shall be sought by Medair for that particular purchase.

Medair reserves the right to enter into a contract with more than one service provider.

This RFP has been issued for the sole purpose of obtaining offers for the staff medical insurance against the specification contained within this document. Medair reserves the right not to enter into or award a contract as a result of this RFP.

The Bidders will not be entitled to claim from Medair any costs or expenses which may be incurred in preparing and / or submitting the tender. This condition applies irrespective of the success of the proposal. It also applies to any additional cost that may incur as part of this competition should Medair modify or amend the RFP requirements or the service design.

Any attempt by the Bidder to obtain confidential information, enter into unlawful agreements with competitors or influence the evaluation committee or Medair during the process of examining, clarifying, evaluating and comparing proposals will lead to the rejection of its offers and may result in the termination of contract where applicable.

Medair reserves the right to reject any proposal or to terminate the contract, if it is determined that the Service Provider is engaged in corrupt, fraudulent, collusive or coercive practices.

Medair shall NOT be bound to accept the lowest priced or any proposal, and reserves the power to accept any part of any proposal, unless the Bidder expressly stipulates to the contrary at the time of proposal submission.

If there is any conflict, it is a fundamental term of the RFP that the Bidder acknowledges and accepts that the terms and conditions of Medair shall prevail.

2. 3 Queries and questions during the RFP period

Service providers are to direct any queries and questions regarding the RFP content or process to the Organisation (Medair) contact person. All questions should be submitted to the nominated email address. Medair may choose to convey responses to submitted questions and queries to all Service Providers so that each is equally informed.

Bidders may submit questions in writing up to 3 days before the deadline for submission of proposals. Medair has no obligation to provide clarifications after this date.

2. 4 Response lodgement methods and requirements

Service Providers must submit one copy of their response to this RFP in any of the following methods:

Electronic copies are to be submitted in PDF and native (eg MS Word) format and Service Providers may submit multiple emails (suitably annotated eg Email 1 of 3) if attached files are deemed too large to suit a single email transmission.

Responses must be prepared in English and in the format requested in Part 3 of this RFP. Hard copy responses must be:

c) Contained in a sealed envelope or package, clearly labelled with the RFP title and reference number; and

d) Loose bound so that pages can be readily separated by Medair.

2. 5 Late responses

Service Providers are responsible for submitting their responses prior to the RFP closing date and time in accordance with the acceptable lodgement requirements described in Clause 2. 4. There will be no allowance made by Medair for any delays in transmission of the response from Service Provider to Medair. Any Proposal received by Medair later than the stipulated RFP closing date and time may be removed from further consideration by Medair.

2. 6 Service Providers to inform themselves

Medair has taken all reasonable care to ensure that the RFP is accurate; however, Medair gives no representation or warranty as to the accuracy or sufficiency of the contained information.

2. 7 Costs of preparing the response

All costs relating to the preparation and submission of a response are the sole responsibility of the Service Provider. Medair shall not pay the Service Provider, wholly or in part, for its response.

2.8 Confidentiality

Except as required for the preparation of a proposal, Service Providers must not, without Medair's prior written consent, disclose to any third party any of the contents of the RFP documents. Service Providers must ensure that their employees, consultants and agents also are bound and comply with this condition of confidentiality.

2. 9 Acceptance of these Conditions

Service Providers, by submitting a response to this RFP, are deemed to have acknowledged and agreed to the conditions set out in this RFP.
