Conditions of bidding

- Fuel price should be DDP to the mentioned locations.
- Supplier should be willing to pre-position fuel in Juba and ready to truck it in different quantities and instructed by SP at different date with in the FWA period.
- Fuel prices provided should be fix for the delivery period of 1 year.
- Products must adhere to East African Diesel quality standards with a surplus index of maximum 500ppm
- SP has sole discretion of caring out background/reference checks on the bidder's operation in South Sudan, this include but not limited to bidders past experience with other organisation.
- The bidder should include minimum of 3 references for similar work with other organisations operation in South Sudan. Failed to do so will result in disqualification of submitted quotation.
- Payment terms will be within 15-30 business days after receipt of fuel, by Electronic bank transfer/checks.
- A reference list.
- Sign SP tender code of conduct and return it alongside quotations.
- Business Contact details including President/Owners of the company.
- Samaritan's Purse is not subject to VAT; therefore, all offers should be exclusive of VAT costs.
- Deadline for submission of bids is <u>February 21st 2020</u> before <u>5:00pm</u>.
- NB: **No tender documents are to be requested from the office**. You only need to submit your quotation as instructed above.
- Should be legally registered company.
- With a track record or experience of <u>supply of Construction Materials</u>.
- Ability and capacity to supply the specified quantities above and deliver to Samaritan's Purse Juba office.
- If submitting in an EMAIL format, **only** bids submitted **solely** to **SouthSudanSealedBid@samaritan.org** will be accepted.
