

## TENDER FOR SUPPLY AND DELIVERY OF QURBANI LIVE BULLS 2025, REF: IRSS-JUB/WA-05/01-25

## **BACKGROUND/INTRODUCTION**

Islamic Relief Worldwide - South Sudan is an international humanitarian organization that has been working with vulnerable communities in South Sudan since 2004. With funding form IR HQ, IRSS is currently implementing a seasonal project named Qurbani in South Sudan. Aimed at improving the food security of the beneficiaries through meat distribution.

Qurbani means sacrifice. Every year during the Islamic month of Dhul Hijjah, Muslims around the world slaughter an animal – a goat, sheep, cow or camel – in remembrance of the sacrifice that Prophet Ibrahim (A.S.) made out of his strong faith in Allah. Ibrahim (AS) showed a willingness to sacrifice his son Prophet Ismail (A.S.) but his son was replaced with a lamb by Allah. Allah was so pleased with Ibrahim's (A.S.) submission to Him that He made this demonstration of sacrifice and faith a permanent part of a Muslim's life. This event is mentioned in Quran - Surah As-Saffat (37:102).

The Qurbani (Udhiya) Programme is implemented in the first three days of Eid al Adha, commencing from the tenth day of the month of Dhul Hijjah. It enables those who can afford to offer the sacrifice but who prefer it to benefit the poor, to donate their qurbani to the poor and needy.

The projects involve the distribution of fresh or chilled meat to the most vulnerable people, such as women, children, the elderly and refugees. Each meat pack is designed to consist of meat that is appropriate and acceptable for the dietary culture of the region.

"That they may witness benefits for themselves and mention the name of Allah on known days over what He has provided for them of cattle. So, eat of them and feed the poor." - Qur'an 22:28

## OBJECTIVE

The Overall purpose of the Procurement is.

- a) To get potential fresh meat suppliers to supply high quality live bull equivalent of minimum 140kgs, slaughter and distribute the meat packs (5 kgs per rightsholders) to IRSS project sites in JUBA and WAU.
- b) To ensure right type, quality and quantity of fresh meat packs are procured and delivered to IRSS project sites (10 Km Radius in JUBA) (10 Km Radius in WAU)

## **DELIVERY DETAILS**

Delivery At Place (DAP) to defined destinations inside South Sudan (10 Km JUBA) (10 Km WAU) as a "just in time" exercise and as a matter of great urgency. (The designated sites shall be provided to the most successful vendor.)

# The supplier should consider the following costs during bidding: QURBANI RULES.

- a. Animal for sacrifice must be healthy and must not be sick and weak such that the animal cannot walk to the place of sacrifice.
- b. Bulls must be free from defects such as: blindness in both or one eye, animals born without ears or a third or more of an ear or the tail cut off, a horn broken off from the root, majority of teeth have fallen out, animals that are squint eyed, animals with total lameness of one or more legs,
- c. Bulls must not be less than two years old.
- d. The days of Qurbani commence after the Eid Al Adha Salaah and continue next three days that follow Eid day, it ends just before sunset of 12th Dhul Hijjah.
- II. A bull must be a minimum of 140 kgs and should be in good health, free from disability or handicap according to the rules of Qurbani stated above. Bulls that are weak, blind, physically disabled, or those who are young, have broken horns or no teeth are ineligible.
- III. The suppliers should also engage with animal veterinary doctors who will examine and ascertain that the animal to be supplied is healthy, free from any diseases and fit for human consumption. You are required to present a certificate of **examination from a government approved veterinarian**.
- IV. The cost should be all inclusive i.e. cost of the live bull, slaughtering cost including skinning, chopping, weighing, packaging, and transporting to the distribution sites in Juba and Wau
- V. Sorting and packaging a minimum of **5 Kgs** of fresh meat per package. Each pack should contain enough meat to meet the needs of an average size local family.
- VI. Transportation cost including loading and off-loading for distribution in designated centers at less than 10Km from the slaughterhouse to the distribution sites in Juba and Wau
- VII. The vendor must use cold refrigerated covered vehicles for transportation of the meat from slaughterhouse to the distribution sites.
- VIII. **Printing of packaging materials** with IRSS branded logo and Qurbani 2025 on all sides of the packaging that can carry minimum **5kgs** of fresh meat.
- IX. The supplier will account for all the animal skins to IRSS.

All tenders are required to be submitted before **Thursday 22<sup>nd</sup> May 2025 10.00 am Local time** pursuant to the attached guidelines for submitting a quotation and be returned to; **HAND DELIVERY TO IRSS TENDER BOX** Hai Cinema, 2nd class, Plot no 52, Block B-XVI, South Sudan upon registration on the bid receipt form. ## **General Terms & Conditions**

- 1. Quoted prices for the above items shall be inclusive of all kinds of Govt. taxes and duties as per prevailing Tax Laws of Govt. of South Sudan, Transportation, and Customs Clearance and port taxes
- 2. All prices must be quoted in USD.
- 3. Supplier will keep animals in one central location of respective area for pre-inspection and selection at least 5 days before Eid.
- 4. Supplier will be responsible for animal fodder, vaccinations, and care during the quarantine period.
- 5. Supplier will be responsible for slaughtering, skinning, chilling, cutting, and packing of meat in food graded plastic bag with IR Logo (Preferably non-transparent) and tie Knotting, blast freeze, and cold chain transportation of packed meat to mentioned areas.

- 6. Bids shall remain valid for at least 90 days from the date of submission. If the last date falls on a holiday, the validity shall be extended to the next working day of the Company thereafter.
- 7. Bids lacking any of the documents listed as Mandatory will lead to automatic disqualification and shall not be considered.
- 8. Supplier will be responsible for proper cleanliness and hygiene of animal keeping and slaughtering area along with proper waste disposal of animal waste after slaughtering, skinning, cutting and packing.
- 9. Supplier will be responsible for providing weighing machines for weighing meat pack (5 Kg).
- 10. Any damage, loss, theft, demurrages and degradation of meat quality before delivery of meat pack at final destination will be the responsibility of the supplier.
