Purpose of the position:

The core responsibilities of this position are to take the lead in overall project implementation, monitoring and reporting of DFAT/ANCP funded project with title " Greater Resilience Through Enhance Agriculture & Nutrition (GREAN) in area of wash intervention in Tonj North in Former Warrap State"

GREAN Project goal is to improve food security and livelihood situations of 72,000 community members from 12,000 vulnerable farmer households in Tonj North and Juba counties in former Warrap and Central Equatoria states. The support will be provided to 12,000 small holders farmers by ensuring that, increased equitable and stable access to WASH facilities for both human use and agricultural production in Juba and Warrap. The project WASH Engineer should ensure project indicators on number of water points built or upgrade as per project goal and objective

Major Roles and Responsibilities:

- Undertake the conceptualization, innovative planning, and proper community mobilization in managing GREAN projects related activities.
- Guide and supervise field assistance and also government staff in mobilizing community, beneficiary selection, identified drilling and construction area.

- Make sure proper documentation of beneficiary screening, training, construction, drilling, hygiene campaigns and meetings.
- Provide technical lead in the area of WASH infrastructures work for the project.
