- 3. Mathematical error of total bided price $>\pm 2$ %.

10. Ownership of tenders

MI reserves/funds ownership of all tenders received. Therefore, bidders will not be able to stipulate requirements that their tenders are to be returned.

11. Opening of submitted tenders.

The tenders will be open on 17th March 2023 in Malteser International Office in Wau by the Evaluation Committee. The selection process will be recorded in writing by the Evaluation Committee.
