





#### COUNTRY PROGRAM OVERVIEW

The overall objective of ALIGHT South Sudan program is to inspire every South Sudanese and provide an enabling environment to unleash abundance! To achieve this objective, ALIGHT implements multi-sectoral programs that include Water and Sanitation, Nutrition, Livelihoods, Protection (GBV) Shelter and Camp Coordination and Camp Management (CCCM). ALIGHT aims to expand its outreach mechanisms and strengthen innovations to provide meaningful and impactful assistance to the affected persons. ALIGHT currently has program activities in Aweil West in Northern Bahr Gazal, Ulang, Nasir, Longechuk and Maiwut in Upper Nile, and Kajo-Keji and Morobo in Central Equatoria States.

### PRIMARY PURPOSE OF THE POSITION

The Field Logistics & Supply Chain Officer is a relocatable position to be based in Aweil West. The incumbent is a senior member of our Logistics & Supply Chain teams. The field Logistics & Supply Chain Office will perform his/her duties under the supervision of the Logistics & Supply Chain Manager.

**Duties and Responsibilities** 

The Field Logistics & Supply Chain Officer is responsible for overseeing the following.

- The position holder is responsible for planning and managing cost effective systems.
- Managing all procurement processes, sourcing, negotiating with vendors, supplier selection and management, maintaining a supplier database, issuing of purchase orders and contracts, reporting, ensuring compliance with Alight procurement policies and donor requirements. Generate procurement reports on time.
- Warehousing management: Responsible for stock and inventory control and generating warehouse reports on time.
- Fleet: The position holder will coordinate and handle vehicle requests from other staff for intown travel and various field destinations. Maintain a logbook

of vehicle movement, mileage, servicing, petrol consumption and general vehicle condition. Perform vehicle daily checks and schedule vehicle servicing and repairs. Ensure vehicles are kept clean and inside and outside, always and that the organization stickers are always visible. Handle annual vehicle inspection and insurance renewal for each vehicle and motorcycle and handle insurance cases of any incidents. Generating fleet reports on time.

- Assets: Ensure all assets are recorded, perform physical.
- IT: Help users troubleshoot technical issues, configure printers and emails for new users. Troubleshoot and resolve network and internet issues and escalate where necessary. On time preparation of IT reports
- Transportation: Assist in organizing transportation of staff and supplies to the field sites. Prepare documentation for staff movement in and out of Aweil. On time preparation of transport reports
- In collaboration with the programme staff, prepare and submit the nutrition commodities requisitions to WFP and/or UNICEF.
- Manage the warehouse in Nyamlel coordination office and oversee the management of the stores at the nutrition sites.
- Coordinate prepositioning of nutrition commodities at the nutrition sites.
- Maintain an inventory of nutrition supplies and compile monthly stocks reports.
- The position holder will ensure that all program activities requiring the support of supply chain units are implemented in a timely manner.
- Perform other duties as assigned by supervisor.

## Administrative/Operations Management:

- Provide leadership for management of administrative & operational activities.
- Effectively manage Alight South Sudan assets, facilities, and administrative and logistical services.
