# Promoting Gender Equality and Resilient Livelihoods in South Sudan (PROGRESS II) Project

## 1. About Islamic Relief South Sudan

Islamic Relief South Sudan (IRSS) – an affiliate of Islamic Relief Worldwide (IRW) has been operating in South Sudan since 2003. IR South Sudan has established itself as a credible humanitarian and development partner with excellent relations at national, sub-national as well as community-levels. This has earned and distinguished IR South Sudan as a dependable actor in the country. IR South Sudan remains committed to reaching the most vulnerable communities across South Sudan through various humanitarian and development interventions. IR South Sudan's philosophy is anchored and aimed at supporting the most vulnerable community members (i.e. IDPs, returnees and host communities). The country office has implemented a variety of programmes focusing on supporting households in crisis situations, especially girls and women, in their protection, training and livelihoods (protection, food security and livelihoods, health and nutrition, WASH, and non-food items) to support IDPs, returnees and host communities.

## **2.** Description of the project

The project "Promoting Gender Equality and Resilient Livelihoods in South Sudan (PROGRESS II)" is a two years integrated intervention in an interlinked multi-sectoral approach (FSL, WASH, Health and Protection) the follow-up phase of PROGRESS-I that is being implemented in Kapoeta East and North Counties, Eastern Equatoria State, South Sudan. The project aims to reduce the vulnerability of drought and conflict-affected communities in South Sudan, through the creation of sustainable livelihoods and improving access to multi-sectorial basic services within FSL, WASH, Health, and Protection in both Counties. The main components of the project include provision and access to trainings, awareness-raising activities, case management, psycho-social support services, community sensitizations, counseling on positive parenting, distributions of agricultural inputs and non-food items, livestock treatment and rehabilitation of water points. In addition, the project will provide healthcare services such as curative consultations, outreaches immunization and antenatal, safe delivery, and post-natal care services. The project goal is "Reduced vulnerability of drought and conflict-affected communities in South Sudan" and its strategic outcomes are:

**Outcome 1:** Enhanced food security and nutrition through resilient agriculture and input distribution among the vulnerable households in Kapoeta East and Kapoeta North;

**Outcome 2:** Improved access to WASH services, including water sources for livestock, create sustainable water sources and improving health condition among target communities of Kapoeta East and Kapoeta North

**Outcome 3:** Improved coverage of equitable Primary Health Care (PHC) services for drought and conflict vulnerable target Communities in Kapoeta East and Kapoeta North

**Outcome 4:** Improved knowledge of protection (GBV) risks and mitigation strategies among women, men, girls, boys in Kapoeta East and Kapoeta North.

A total of 13,500 individuals (3,645 men, 4,725 women, 1,755 boys and 3,375 girls including 1,350 persons with disabilities) will be reached through an integrated approach targeting the conflict and drought-affected communities in the proposed project locations.

## 3. Purpose of the Baseline Study

Primary objectives of the baseline study:



- To determine and provide quantitative baseline values for the indicators against which progress will be assessed or comparisons made;
- To validate the suitability of the indicators in terms of the measurability of the project objectives and, if necessary, make suggestions to refine and adjust indicators and target values;

Secondary objective of the baseline study:

• Provide recommendations on how to improve projects programmatically

## 4. Methods for Data Collection and Analysis

The selected consultant(s) will design a research methodology and a work-plan for the baseline study. A mix of qualitative and quantitative methods will be used: the indicator values will be determined through quantitative methods such as surveys. For reasons of triangulation, validation and quality assurance, additional qualitative data collection methods such as focus group discussions and Key Informant Interviews (KIIs) and Observations will be conducted. It is expected that the consultant(s) will develop a detailed methodology for data collection, sampling methodologies for both the quantitative and qualitative data collection methods, and a data management and analysis plan. Sources of data should be properly documented, and data disaggregated by sex, age group (>18 and <18) and disability and any other context-specific relevant criteria during collection and analysis.

All suggested tools will be discussed with the project team before finalization and should be shared with the project teams as part of the deliverables. The project team will share with the consultant all the project documents. Additional secondary data sources might be used in the document review.

## 4.1 Sampling

The consultant (s) is expected to develop and suggest sampling strategies for all proposed methods of data collection, quantitative and qualitative. Sample sizes for quantitative data collection must representative of the respective beneficiary population. A 95% confidence interval and 5% margin of error to determine the sample is required.

The sample size for the qualitative data collection method should be clearly defined, including the selection criteria of participants.

## 4.2 Participant Selection

Key stakeholders and target groups to be involved:

- Children, adolescents, and adults;
- Project team members;
- Parents and caregivers;
- Community leaders:
- Youth leaders;
- Health workers;
- Local authority representatives;
- National and international stakeholders.
- And other relevant stakeholders



## 5. Ethical Considerations

The below ethical considerations will be adhered to during the evaluation survey:

- IRSS recognizes the personal dignity and rights of children and vulnerable adults, towards whom it has a special responsibility and duty of care and respect. The consultant is expected to adhere to IRW Safeguarding policy and sign as an appendix to their contract of engagement and agree to conduct themselves in accordance with the provisions of these documents.
- Quantitative data will be obtained from a randomly selected representative population sample.
- Assert that their participation in the survey will be voluntary and they are aware that they can opt-out at any time. (Note that participants may leave or refuse to answer any question at any time and that this will not affect their standing with the organization)
- Anonymity, confidentiality and safeguarding of survey data will be guaranteed.
- There will be no risks and benefits for individual participants
- The culture, norms and traditions of study populations will be respected.
- Consent will be sought prior to commencing data gathering
- Views and opinions of the different survey subjects will be respected.
- For interviews with children, there will be an informed consent process to ensure that all children, their parents/guardians and vulnerable adults are fully aware of all aspects of the evaluation process and voluntarily provide their consent to take part. All caregivers/guardians will be asked to provide informed consent for children's participation in the study, in line with UNCRC's recognition of children's evolving capacities and a parent/guardian's responsibility to ensure a child's well-being and safety.
- All the respondent's data will be kept in confidential way and shared only with the consent of IRSS

## 6. Users of the Baseline Study Report

The main users of the baseline report will be the project team members, beneficiaries, community members and donors.

## 7. Key Baseline Deliverables and format

Deliverables expected from the consultant:

- Draft Inception Report including: an updated timeline, detailed methodology, including draft sampling methodology and size; draft data collection tools, ethical considerations, methods for data analysis, brief justification of the methods and techniques used (including relevant underlying values and assumptions/theories) with a justification of the selections made (e.g. of persons to be interviewed).
- Final Inception Report incorporating feedback from IRW South Sudan
- Draft Baseline Report including an Indicator Tracking Table with baseline data inserted.
- Validation workshop of the Baseline report with PPT presentation
- Final Baseline Report (including Executive Summary).
- Final Sampling methodology (including unit of sampling and sampling frame) and size.
- Final Data Collection Tools.



- Cleaned Data (including data files (e.g., Excel, SPSS, Kobo, Nvivo), transcripts of qualitative data, syntax/ codebooks etc.)
- Review of logical framework and propose proxy indicators if needed to assess the immediate impact and outcome of the project and submit the Indicator summary sheet
- Monitoring toolkit and dashboard where possible

- Ability to work well both independently and in a team
- Excellent conflict-sensitive approaches and ability to work in highly sensitive environments

## **11. Applications and Quotation Requirements**
